

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2024-200**

A RESOLUTION OF THE CITY COMMISSION DIRECTING CITY STAFF TO PRESENT AN ADDITIONAL OPTION FOR THE CONSTRUCTION OF SIDEWALKS ALONG PORTIONS OF ALHAMBRA CIRCLE.

**WHEREAS**, during the September 10, 2024 Commission meeting staff presented an update on the balloting for sidewalks along a portion of Alhambra Circle; and

**WHEREAS**, following a presentation by City staff and public comment the City Commission determined that City staff should consider and present to the City Commission an additional option for the construction of the sidewalk along portions of Alhambra Circle; and

**WHEREAS**, City staff is directed to continue with the planned traffic calming in the area with the assumption that any future sidewalk will not be adjacent to the road;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the Coral Gables City Commission hereby directs City staff to return to a future City Commission meeting and present an additional option for the construction of sidewalks along portions of Alhambra Circle.

**SECTION 3.** That the Coral Gables City Commission hereby directs City staff to continue with the planned traffic calming in the surrounding area with the assumption that any future sidewalk will not be adjacent to the road.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.




