RESOLUTION NO. 2026-36

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER TO DIRECT CITY STAFF TO CONDUCT A COMMUNITY MEETING TO OBTAIN PUBLIC INPUT REGARDING THE PROPOSED DOG PARK ON THE CITY-OWNED PROPERTY LOCATED AT 520 UNIVERSITY DRIVE; PROVIDING FOR A REPORT BACK TO THE CITY COMMISSION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Coral Gables is committed to ensuring that the planning and development of public parks and recreational facilities are informed by meaningful community input; and

WHEREAS, on November 18, 2025, the City Commission adopted Resolution No. 2025-426 authorizing City staff to move forward with the development of a dog park on the property located at 520 University Drive (the "Property"); and

WHEREAS, members of the public have expressed interest in providing additional input regarding the proposed use of the Property; and

WHEREAS, the City Commission desires that City staff facilitate a community meeting for the purpose of receiving and documenting such input on the proposed dog park;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission hereby directs the City Manager to direct appropriate City staff to organize and conduct a community meeting to receive public input regarding the proposed dog park on the City-owned property located at 520 University Drive.

SECTION 3. City staff shall compile the comments and feedback received at the community meeting and prepare a written summary for presentation to the City Commission.

SECTION 4. That this Resolution shall become effective immediately upon the date of its passage and adoption herein.


