**RESOLUTION NO. 2025-464**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION CITY MANAGER TO APPROVE A CHANGE ORDER TO INCREASE THE SPENDING AUTHORITY ON THE ALTURNATECH GS-35F-011Y-1 CONTRACT IN THE ESTIMATED AMOUNT OF \$600,000.00, PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED CHANGE ORDERS AND CONTRACT MODIFICATIONS".

**WHEREAS**, on December 11, 2011, the City officially accessed contract # GS-35F-0119Y-1 awarded to Alturnatech: and

**WHEREAS**, the contract is primarily utilized for the purchase of information technology hardware equipment, software, licensing and services utilized to support ongoing operations for public safety, general government and citizen services; and

**WHEREAS**, there is a need to increase the spending authority for the contract through the existing term which expires in December 19, 2026; and

**WHEREAS**, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards; and

**WHEREAS**, it is necessary to seek additional spending authority to address any future needs required to complete future projects, renewal of support and maintenance agreements as well as hardware and software refresh cycles;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation and authorizes the City Manager to increase the Alturnatech GS-35F-0119Y-1 in an estimated amount of \$600,000.00 not to exceed the available budget, to acquire hardware equipment, software licenses and products, and peripheral pursuant to Section 2-764, Approval of Change Orders and Contract Modifications of the Procurement Code.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.




