RESOLUTION NO. 2025-243

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA, REQUESTING ADLER GUERRIER SUBMIT A PROPOSAL FOR A PUBLIC ART PROJECT FOR CITY CONSIDERATION.

WHEREAS, Adler Guerrier is an internationally recognized artist, Coral Gables resident, and longstanding member of the City’s Cultural Development Board, whose artwork has been exhibited at prestigious venues such as the Whitney Biennial, Art Basel, and international galleries; and

WHEREAS, during the July 1, 2025, City Commission meeting, the Commission recognized Mr. Guerrier’s contributions to the local and global arts community and expressed a strong desire to see his work commissioned for public display in the City of Coral Gables; and

WHEREAS, the City Commission wishes to formally request that Mr. Guerrier collaborate with City staff and return to the Commission with a proposed public art piece that reflects the City’s history, character, and cultural identity, particularly in light of the upcoming Centennial Celebration;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, AS FOLLOWS:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission hereby requests that artist Adler Guerrier collaborate with the City Manager’s Office and City staff to develop and present a proposal for a public art piece to be located within the City of Coral Gables, subject to compliance with applicable rules and regulations.


SECTION 3. Mr. Guerrier is encouraged to consider themes that honor the City’s legacy, founders, and unique cultural landscape in preparation for the Centennial.

SECTION 4. The proposal shall be submitted for City Commission consideration in September, 2025.

SECTION 5. This Resolution shall become effective upon the date of its passage and adoption herein.


