**RESOLUTION NO. 2025-180**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO REQUEST ADDITIONAL SPENDING AUTHORITY IN THE AMOUNT OF \$800,000.00 FOR A CONTRACT AWARDED TO INSIGHT PUBLIC SECTOR, INC. PURSUANT TO SECTION 2- 764 (B) OF THE CITY'S PROCUREMENT CODE ENTITLED CHANGE ORDERS AND CONTRACT".

**WHEREAS**, on April 24, 2019, the City officially accessed contract 20043-Technology Products and Services awarded to Insight Public Sector, Inc.; and

**WHEREAS**, this contract will be used to procure services and products that support day to day operations City wide to include, but not limited to: backup and disaster recovery infrastructure, and fiber optic network infrastructure, interconnectivity of City sites as well to renewal of services and maintenance of Mark 43 software used by Police and Fire. Insight Public Sector, Inc. has a vast catalog of hardware, services and technology solutions that can be acquired using this single source; and

**WHEREAS**, there is a need to increase the spending authority for the contract through the existing term which expires on June 4 2028; and

**WHEREAS**, Section 2- 585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

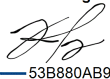
**SECTION 1.** The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the City Manager and authorizes the City Manager to increase the OMNIA Contract # 20043-Technology Products and Services with Insight Public Sector, inc. in an estimated amount of \$ 800,000.00 not to exceed the available budget, to acquire hardware equipment, services and products, and peripheral pursuant to Section 2-764(b), Approval of Change Orders and Contract Modifications of the procurement code.

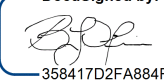
**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
