RESOLUTION NO. 2025-325

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF GRANT AGREEMENT NO. PW006 WITH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT IN THE AMOUNT OF \$250,000 ALLOCATED TO THE CORAL GABLES POLICE DEPARTMENT FOR THE PURCHASE OF A HIGH WATER RESCUE VEHICLE; AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE GRANT FUNDS AS REVENUE; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT FOR SAID FINANCIAL ASSISTANCE

WHEREAS, the City of Coral Gables has been awarded Grant Agreement No. PW006 by the Florida Department of Law Enforcement in the amount of \$250,000, pursuant to a nonrecurring appropriation under Line 1177 of the General Appropriation Act for the 2025-2026 State Fiscal Year; and

WHEREAS, the Agreement provides the City funds to support the purchase of a high-water rescue vehicle with standard options, a transport trailer, a tow vehicle, and items to outfit the high-water rescue vehicle; and

WHEREAS, the high-water rescue vehicle significantly strengthens the Coral Gables Police Department’s border protection capabilities by providing enhanced mobility along the City’s extensive coastline and flood-prone areas; and

WHEREAS, these new vehicles will improve the Police Department’s ability to respond to emergencies in flooded regions throughout the state; and

WHEREAS, the City Manager is authorized to execute Grant Agreement No. PW006, as well as any future amendments to this agreement;

NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the forgoing “**WHEREAS**” clauses are hereby confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.

SECTION 2. That the City Commission does hereby authorizes the acceptance of Grant Agreement No. PW006 from the Florida Department of Law Enforcement in the amount of \$250,000 for the purchase of a high-water rescue vehicle, a tow vehicle, a transport trailer and items to outfit the high-water rescue vehicle.

SECTION 3. That the City Commission hereby authorize the City Manager to execute Grant Agreement No. PW006 and any future amendments to this grant agreement.

SECTION 4. That the City Commission does hereby authorize an amendment to the Fiscal Year 2024-2025 annual budget to recognize the \$250,000 grant as revenue and to appropriate the funds to be used towards the cost of the program.


