Transportation Advisory Board

Description

MEMBERSHIP: Seven (7) members with the five (5) City Commissioners appointing one member each, one (1) member to be appointed by the Commission-As-A-Whole, and one (1) member to be nominated by the City Manager, with all appointments being confirmed by the Commission.

CHAIRPERSON: The Transportation Advisory Board shall elect from among its membership, a Chairperson who shall serve for a period of one (1) year and may be named to successive terms if the board chooses.

QUORUM: Meetings shall be called to order when a quorum is present.

FUNCTION: The purpose of the Board shall be to identify and recommend improvements to develop transportation connectivity of all modes to provide a variety of transportation alternatives. One of the primary objectives of this Board would be to maintain a well-integrated urban street grid, providing access to commercial centers without sacrificing the high quality of life that exists within city neighborhoods. It will review traffic calming opportunities and recommend policies to apply in City neighborhoods. The ultimate goal would be to effectively protect and maintain the multi-modal transportation network and the safe and effective use of public rights of way.

ANNUAL REPORT: Pursuant to Ordinance 2005-02, Sec. 2-66 the Chairperson shall submit an Annual Report, approved by the board, to the City Manager by October 1st of each year. Said report shall include the following information: 1). Whether the board is serving its purpose; 2). A list of the board's major accomplishments; 3). Whether the ordinance creating the board should be amended; 4). Whether the board's membership requirements should be modified; 5). The costs both direct and indirect, of maintaining the board; 6). A report on authorized fundraising, bank accounts, grant applications and approvals, etc.

RESIDENCY REQUIREMENT: Members must be resident of the City and shall have resided in the City for six (6) months prior to their appointments.

REMUNERATION: None.

MEETINGS: The board meets at 5:30pm on the third Tuesday of every month.

Parking Advisory Board

Description

MEMBERSHIP: Pursuant to Resolution No. 2005-125, the Parking Advisory Board members shall consist of five (5) members appointed by the Members of the Commission, and confirmed by the Commission.

CHAIRPERSON: Members shall elect their own Chairperson, at the first meeting of each term.

MEETINGS: Members shall meet at least once a month at a time to be set at the call of the Chairman or Secretary.

QUORUM: Except for those boards whose creating resolution or ordinance provides otherwise, a quorum for all boards meetings shall consist of fifty (50) percent plus one of the board's total memberships.

FUNCTION: To investigate any and all matters relating to parking problems within the City of Coral Gables and recommend to the City Commission on the feasibility of acquiring, leasing, operating or disposing of real estate property and the enforcement of rules in connection with the operation of parking facilities throughout the City.

ANNUAL REPORT: Pursuant to Ordinance No. 2005-02, Sec. 2.54, the Chairperson shall submit an Annual Report, approved by the board, to the City Manager by October 1st of each year. Said report shall include the following information: 1). Whether the board is serving its purpose; 2). A list of the board's major accomplishments; 3). Whether the ordinance creating the board should be amended; 4). Whether the board's membership requirements should be modified; 5). The costs both direct and indirect, of maintaining the board; 6). A report on authorized fundraising, bank accounts grant applications and approvals, etc.

RESIDENCY REQUIREMENT: Qualified Members may be appointed to the Board who are not residents, if it has been determined by the Commission that the Board is composed of such number of citizens as the Commission deems expedient, pursuant to Sec. 88 of the City Charter and Sec. 2-59(b) of the City Code.
