RESOLUTION A ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE KINGS BAY STREETSCAPE IMPROVEMENT CONTRACT FLORIDA CONSTRUCTION & ENGINEERING, INC., PURSUANT TO INVITATION FOR BID (IFB) 2015.06.18, AND SECTION 2-828 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on June 18, 2015, the Procurement Division of Finance formally advertised, issued, and distributed the Kings Bay Streetscape Improvement IFB 2015.06.18; and

WHEREAS, on June 26, 2015, a non-mandatory pre-bid conference was held with three (3) prospective bidders in attendance of the sixteen (16) prospective bidders who obtained the IFB package from the Procurement Division; and

WHEREAS, on July 20, 2015, two (2) bid were received in response to the IFB 2015.06.18 for Kings Bay Streetscape Improvement from Florida Construction & Engineering, Inc and ABC Construction, Inc.; and

WHEREAS, the lowest responsive and responsible bid was submitted by Florida Construction and Engineering, Inc., in the amount of \$397,649.25; and

WHEREAS, the Chief Procurement Officer pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Invitation for Bid (IFB) 2015.06.18 recommends that Florida Contraction & Engineering, Inc., be awarded the Kings Bay Streetscape Improvement contract; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the Public Works Department and City's project consultant, AECOM Technical Services, Inc., concur with the recommendation of the Chief Procurement Officer to award the Kings Bay Streetscape Improvement Project to Florida Construction & Engineering, Inc.;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Kings Bay Streetscape Improvement contract to Florida Construction & Engineering, Inc., pursuant to Invitation For Bid (IFB) 2015.06.18, and Section 2-828 of the Procurement Code entitled "Contract Award", subject to final approval and execution of a contract by City staff.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
