**RESOLUTION NO. 2009-115**

A RESOLUTION AUTHORIZING THE EXTENSION OF A CONTACT WITH GYM KIDZ, INC., PURSUANT TO SECTION 2-834 (D) OF THE PROCUREMENT CODE FOR A PERIOD NOT TO EXCEED ONE HUNDRED TWENTY (120 DAYS FROM THE EXPIRATION OF THE CURRENT CONTRACT FOR THE PROVISION OF GYMNASTIC PROFESSIONAL SERVICES.

**WHEREAS**, on February 9, 2004 the City Commission approved a contract with Gym Kidz, Inc., for the provision of gymnastic professional services; and

**WHEREAS**, said contract provided for an initial two (2) year term with an option to renew for three (3) additional one (1) year terms with the last term expiring June 1, 2009; and

**WHEREAS**, the Procurement Division of Finance formally solicited proposals for gymnastic professional services on January 30, 2009 under RFP 2009.01.22 with proposals required be submitted by March 5, 2009; and

**WHEREAS**, after the Selection Committee evaluated the proposals, concerns were expressed by service providers regarding the evaluation process, and as a result the Chief Procurement Officer cancelled the RFP under Section 2-733, Cancellation of Competitive Sealed Bids or Proposals, of the Procurement Code; and

**WHEREAS**, under Section 2-834 (d) of the Procurement Code this Gymnastics Professional Services Contract should be extended for a period not to exceed one hundred twenty (120) days from the expiration date of the current contract (June 1, 2009) to provide sufficient time to rebid; and

**WHEREAS**, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the extension of the gymnastics professional services contract for a period not to exceed one hundred twenty (120) days from the expiration of the current contract (June 1, 2009) with Gym Kidz, Inc., to provide sufficient time for this contract to be rebid.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


