### **D. PUBLIC COMMENTS**

Comments provided by Marlene Hernandez via Zoom, Mari Tere Rojas's Chief of Staff- Items referenced below are those proffered by Chair Rojas during April:

- **B-2** - Resolution 26021 of the School Board of Miami-Dade County recognizing - Amigos for Kids. Organization was founded in 1991 is a trusted and long-standing nonprofit organization dedicated to the prevention of child abuse and neglect by strengthening families, educating communities, and empowering children to thrive. For more than three decades, Amigos for Kids has served as a pillar of support for the Miami-Dade County, providing comprehensive, evidence informed programs that uplift vulnerable families, promote healthy child development, and create pathways to opportunity.

- **H-2** – Matters related to the Comprehensive integrity-based selection and Appointment Process for the Next Superintendent of Schools discussed at the Scheduled School Board Workshop Tuesday, April 14, 2026.
- **H3-** Endorsement of May 1, 2026 as School Lunch Hero Day in Miami-Dade County Public School. This is a celebration to show our appreciation to the professionals who make Meals for America students, and this team includes the specialists and managers who develop and implement rigorous nutritional standards, as well as a committed cafeteria staff who ensures that every student is served each day in Miami-Dade County Public Schools.
- **H-4-** Endorsement of May 5, 2026 as National Teacher, and May 4 thru May 8, 2026, as Teacher Appreciation Week in Miami-Dade County Public Schools. Teacher Appreciation Week provides an important opportunity to highlight for the Miami-Dade County community the significant contribution, since teachers make the lives of their students.
