RESOLUTION NO. 2025-236

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF A KEEP AMERICA BEAUTIFUL CIGARETTE LITTER PREVENTION & RECYCLING GRANT IN THE AMOUNT OF \$2,500 TO BE PUT TOWARDS THE “KEEP CORAL GABLES BEAUTIFUL” CIGARETTE LITTER PREVENTION & RECYCLING PROGRAM; AUTHORIZING THE EXECUTION OF THE GRANT AGREEMENT; AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024-2025 ANNUAL BUDGET TO RECOGNIZE THE \$2,500 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE COST OF THE PROGRAM.

WHEREAS, the City was awarded a Keep America Beautiful Cigarette Litter Prevention & Recycling Grant for the Keep Coral Gables Beautiful (KCGB) program in the value amount of \$2,500; and

WHEREAS, the grant is comprised of \$2,500 cash award, as well as, pocket ashtrays, auto ashtrays, and receptacle collection envelopes as an in-kind donation for KCGB’s use; and

WHEREAS, an amendment to the Fiscal Year 2024-2025 Annual Budget is required to recognize the \$2,500 grant as revenue and to appropriate the funds towards the cost of the program; and

WHEREAS, the primary objective of the grant is to promote the Cigarette Litter Prevention & Recycling program by increasing public awareness, educational outreach, and ensuring existing receptacles are maintained to further reduce cigarette litter in public spaces;

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the forgoing “**WHEREAS**” clauses are hereby confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein.

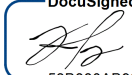
SECTION 2. That the City Commission does hereby authorizes the acceptance of the Keep America Beautiful Cigarette Litter Prevention & Recycling Grant in the amount of \$2,500 towards the Keep Coral Gables Beautiful program.

SECTION 3. That the City Commission does hereby authorizes the City Manager to execute the grant agreement with Keep America Beautiful.

SECTION 4. That the City Commission does hereby authorize an amendment to the Fiscal Year 2024-2025 annual budget to recognize the \$2,500 grant as revenue and to appropriate the funds to be used towards the cost of the program.

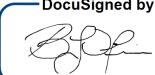

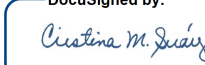
