

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2008-83**

A RESOLUTION FROM THE CITY COMMISSION ENDORSING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S PLAN TO INSTALL SIDEWALKS ALONG BIRD ROAD BETWEEN RED ROAD AND RIVIERA DRIVE, SO THAT IT CAN START THE SURVEYING AND PUBLIC INFORMATION MEETINGS; FURTHER PROVIDING THAT THE FLORIDA DEPARTMENT OF TRANSPORTATION WILL REPORT BACK TO THE CITY REGARDING THE FINAL PLAN PRIOR TO ITS IMPLEMENTATION.

**WHEREAS**, the Florida Department of Transportation needs to comply with the ADA requirements along this corridor; and

**WHEREAS**, the Florida Department of Transportation needs to provide a continuous sidewalk corridor in order to meet ADA requirements; and

**WHEREAS**, the Florida Department of Transportation has asked the City of Coral Gables to grant its permission so that it may proceed with survey and public information meetings with the area residents for the construction of new sidewalk along Bird Road from S. W. 57<sup>th</sup> Avenue to Riviera Drive, to comply with ADA requirements; and

**WHEREAS**, the Florida Department of Transportation will report back to the City Commission regarding the final plan prior to its implementation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the Florida Department of Transportation is hereby granted permission to proceed with the survey and public information meetings for the construction of new sidewalk along Bird, Road, from S. W. 57<sup>th</sup> Avenue to Riviera Drive, to comply with ADA requirements.

**SECTION 3.** That the Florida Department of Transportation will report back to the City Commission regarding the final plan prior to its implementation.

**SECTION 4.** That this Resolution shall become effective upon the date of its adoption herein.
