**RESOLUTION NO. 2026-89**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE PRE-QUALIFIED POOL OF PROFESSIONAL TENNIS INSTRUCTORS PREVIOUSLY AWARDED FOR PROFESSIONAL TENNIS SERVICES, REQUEST TO QUALIFY 2020-010, PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS". FURTHER AUTHORIZING, THE ABILITY TO AWARD CONTRACTS, AND TO ADD QUALIFIED TENNIS AND PICKLEBALL INSTRUCTORS TO THE PRE-QUALIFIED POOL WHEN DEEMED IN THE CITY'S BEST INTEREST WITHOUT FURTHER CITY COMMISSION ACTION.

**WHEREAS**, on December 8, 2020, the City Commission adopted Resolution No. 2020-259 authoring the Chief Procurement Officer to award a pre-qualified pool of professional tennis instructors, Request to Qualify (RTQ) 2020-010 for Professional Tennis Services; and

**WHEREAS**, the purpose of this contract is to provide a pre-qualified pool of instructors for tennis instructor services. A total of thirty-three (33) instructors to date have qualified under this pre-qualified pool of instructors; and

**WHEREAS**, the established pre-qualified pool may be amended as necessary to add additional qualified instructors; and

**WHEREAS**, on February 7, 2023, the RTQ was amended to include pickleball instructors as an additional service; and

**WHEREAS**, it is recommended that the RTQ contract be extended for six (6) months to allow for the continuation of services, with the option to continue on a month-to-month basis thereafter, if necessary, until a replacement contract is awarded; and

**WHEREAS**, it is recommended that all professional instructors (tennis and pickleball) pre-qualified via RTQ 2020-010 be grandfathered into the extended term of the contract and the replacement contract upon award; and

**WHEREAS**, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards; and

**WHEREAS**, the contract may be extended under Section 2-764 of the Procurement Code entitled “Approval of Change orders and Contract Modification”;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to extend contract RTQ 2020-010 for Professional Tennis Instructors, pursuant to Section 2-764 of the Procurement Code entitled “Approval of Change Order and Contract Modifications,” for six (6) months with the option to continue on a month-to-month basis thereafter, if necessary, until a replacement contract is awarded.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


