RESOLUTION NO. R-2003-217

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER APPROVING THE DECISION PURSUANT TO THE REQUEST FOR PROPOSAL (RFP) TO SELECT STANDARD PARKING CORPORATION, TO PROVIDE PARKING CASHIER AND CUSTODIAL SERVICES; AND, FURTHER AUTHORIZING THE CITY MANAGER TO SIGN AND EXECUTE A CONTRACT FOR AN INITIAL PERIOD OF TWO (2) YEARS WITH AN OPTION TO RENEW FOR THREE (3) ADDITIONAL ONE (1) YEAR PERIODS FOR A NOT TO EXCEED AMOUNT OF \$150,834.00 PER YEAR.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

WHEREAS, on July 25, 2003, the Purchasing Department advertised a Request for Proposal for Parking Cashier and Custodial Services of which nine (9) proposals were distributed; and

WHEREAS, on August 21, 2003, the Purchasing Department received a total of four (4) responses to the Request for Proposal for Parking Cashier and Custodial Services from Standard Parking Corporation, Central Parking, AAA Parking, and Seven One Seven Parking; and

WHEREAS, on October 3, 2003 the Parking Cashier and Custodial Services Evaluation Committee convened to review the four (4) responsive proposals from the above mentioned firms; and

WHEREAS, the proposals were ranked and the selection committee unanimously selected Standard parking Corporation as the highest ranked, responsive, responsible proposer; and

WHEREAS, Standard Parking Corporation's rate of \$11.50 per hour will allow the City of Coral Gables to realize a cost savings of \$22,821.84 per year or \$114,109.20 over the life of the five year contract when compared to the proposed \$13.24 per hour rate of AAA Parking; and

WHEREAS, The City of Coral Gables Commission accepts the recommendation of the City Manager approving the decision of the Evaluation Committee pursuant to the Request for Proposal (RFP); and

WHEREAS, the City Commission authorized the City Manager to execute a contract for Parking Cashier and Custodial Services with Standard Parking Corporation, for an initial period of two (2) years with an option to renew for three (3) additional one (1) year periods; and

WHEREAS, the Finance Director authorized to expend the aforesaid funds for the provision of Parking Cashier and Custodial Services; and

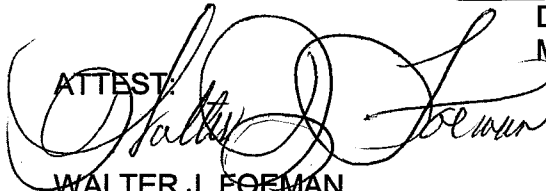
Said resolution shall become effective upon the date of its adoption herein.
