Mayor Valdes-Fauli: I want to congratulate the -- our Commissioner Lago for, again, taking the

this out of necessity, one way or another. So, I think the fact that we're doing it today in a

progressive manner, I think it's going to pay a lot of dividends in the future.

Mayor Valdes-Fauli: Of course.

Vice Mayor Keon: I know that we've had some residents come to us that are in existing

buildings that don't have charging stations or anything in them. Is there anything we can do...?

Commissioner Lago: That's...

Vice Mayor Keon: With regard to that?

Commissioner Lago: And, I wish I had Peter here, because Peter is really a guru when it comes

to everything engineering.

City Manager Swanson-Rivenbark: He's going to be here...

Commissioner Lago: Yeah. We can address it later, but the issue -- the main issue is obviously

having some sort of dedicated electrical already in place.

Vice Mayor Keon: Right.

Commissioner Lago: And, the costs when you're building the building are a lot less stressful

than when you have an existing building and you have to run that electrical. So, what ends up

happening is now a lot of the buildings, as per our LEED ordinance, are required to offer this

type of service. So, it's a problem that you won't have in future buildings...

Vice Mayor Keon: Right.

Commissioner Lago: And, I wish existing build...

Vice Mayor Keon: But, bringing them into the existing...

Commissioner Lago: So, what ends up happening is you're seeing a lot of people being forced to either move out of the building or to house their vehicles in an adjacent building that actually

has...

Vice Mayor Keon: That has a charging station.

Commissioner Lago: That actual service.

Vice Mayor Keon: But, aren't exhaust fans and those types of things, don't they run off of 240?

Commissioner Lago: They...

Vice Mayor Keon: So, they have to have them in the garages, because of the exhaust.

Commissioner Lago: They do.

Vice Mayor Keon: They must have that electric in there somewhere.

Commissioner Lago: They do.

Vice Mayor Keon: Oh, but the cost to do it, okay.

Commissioner Lago: It's very...

Vice Mayor Keon: And, we really can't mandate that.

Commissioner Lago: It's cost prohibitive.

Vice Mayor Keon: Yeah.

Commissioner Lago: And, then what ends up happening is a lot of the associations will say, you

know -- then they put the burden on the owner of the electric vehicle, which, again, it shouldn't

be the case, because right now it's going to become a more -- I mean, you're seeing a wave of

people buying electric vehicles.

Vice Mayor Keon: Oh, absolutely.

Commissioner Lago: Because it just makes sense. And right now, you have gas around \$2.30,

\$2.40, \$2.50. Imagine when -- if it ever goes back up...

Vice Mayor Keon: When it goes back up...

Commissioner Lago: You know, \$3, \$4 or \$5.

Vice Mayor Keon: Yeah.

Commissioner Lago: It becomes -- it makes sense now already because, again, solar is

becoming so cheap. But those gas prices do start peaking again, which, eventually, they will -- I

mean, it ebbs and flows -- you'll see that everybody will start -- you know, electric vehicles will

become even more prevalent.

Vice Mayor Keon: Is there any issue with retrofitting a garage to do that other than -- it's just

the expense? But there's no problem with it.

Commissioner Lago: Just the expense. So, we've had...
