If you do not perform the Corrective Actions above and pass any necessary compliance inspections by the Building Official within the timeframes provided, the City may also declare the Structure unsafe and take additional emergency action.

Pursuant to Section 105-96 of the City Code, the City may order that the Structure be vacated immediately and may secure the Structure itself ("Emergency Action"). Additionally, the City may request that Florida Power & Light, without any further notice, disconnect the power to the Structure. The City may also impose a special assessment lien on the Property for the costs of the Emergency Action, pursuant to Section 105-98 of the City Code. Finally, the City may also take further enforcement action, including, but not limited to, commencing an unsafe structures proceeding.

Please note that it shall be unlawful for any person, firm, or corporation or their agents to remove this notice without written permission from the Building Official.

You have the right to appeal this decision to the City's Construction Regulation Board.

**NOTICE OF UNSAFE STRUCTURE VIOLATION
AND NOTICE OF HEARING**

Date: July 29, 2025

Re: 3807 Durango St, legally described as CORAL GABLES COUNTRY CLUB SEC 3 PB 10-52; LOTS 1 & 26 & 27 BLK 44; LOT SIZE 17300 SQ FT and bearing Property Appraiser's folio number 03-4118-005-1460 ("Property"), and the single-family home on the Property, built in 1941 ("Structure").

The City of Coral Gables ("City") Building Official has inspected the records relating to the Structure in accordance with Article III, Chapter 105 of the City Code, pertaining to unsafe structures. **The Structure is hereby declared unsafe** by the Building Official and is presumed unsafe pursuant to Section 105-89 of the City Code; as follows:

Sec. 105-89. Physical criteria for unsafe structures.

A structure shall be considered unsafe if it meets any of the following criteria:

- (1) The structure or its electrical, gas, mechanical, or plumbing system is unsafe; dangerous; unsanitary; does not provide adequate egress; constitutes a fire or windstorm hazard; is otherwise dangerous to human life; by reason of illegal or improper use, occupancy or maintenance, constitutes a hazard to safety or health or public nuisance; or has been substantially damaged by the elements, fire, explosion, or otherwise.
- (2) The structure constitutes a hazard to safety or health by reason of inadequate maintenance, dilapidation, obsolescence, or abandonment.
- (10) A structure shall be presumed to be unsafe if one or more of the following criteria applies:
 - a. There is falling-away, hanging, or loose siding, blocks, bricks, or other building material.
 - b. The structure or its structural parts are deteriorated.
 - d. There is an unusual sagging or leaning out of plumb or square of the structure and such effect is caused by deterioration or over-stressing.
 - f. An unsanitary condition exists by reason of inadequate or malfunctioning sanitary facilities or waste disposal systems.
 - h. The structure is in violation of the minimum housing code of article V of this chapter. (See sections 250, 251, 252, and 278 of Chapter 101 of the City Code.)

1. The structure or part thereof meets any of the physical criteria of an unsafe structure set forth above and has not been repaired and brought into compliance with the applicable codes following the expiration of a reasonable notice period.

Specifically:

1. There is no potable water service to the Structure, because of damaged pipes.
2. The roof and eaves of the Structure are in disrepair. The roof is sagging and in danger of collapse and the eaves are falling-away, hanging, or loose.
3. The front door to the Structure does not close and cannot be locked.

You must secure the Structure, so that the door is closed and locked and there are no broken windows, within 30 days of the date of this notice. Apply for obtain, and pass final inspection on all development approvals, including, but not limited to, building permits (“Permits”) to repair the Structure (“Required Action”), within 90 days of the date of this notice.

Therefore, this matter is set for hearing before the City's Construction Regulation Board (“Board”) in the Fairchild Tropical Board Room, 427 Biltmore Way, 1st Floor, Coral Gables, Florida 33134, on August 11, 2025, at 2:00 p.m.

You may appeal the decision of the Building Official to the Board by appearing at the hearing. You have the right to be represented by an attorney and may present and question witnesses and evidence; however, formal rules of evidence shall not apply. Failure to appear at the hearing will result in the matter being heard in your absence. Please be advised that if someone other than an attorney will be attending the hearing on your behalf, he or she must provide a power of attorney from you at the time of the hearing. Requests for continuance must be made in writing to Analyn Hernandez, Secretary to the Board, at City of Coral Gables, Development Services Department, 427 Biltmore Way, Coral Gables, FL 33134, ahernandez2@coralgables.com, tel: (305) 460-5235. The Development Services Department's hours are Monday through Friday, 7:30 a.m. to 2:30 p.m.

If the Required Action is not completed before the above hearing date, the Building Official may order that the structure be vacated, boarded, secured, and posted (including but not limited to, requesting the electric utility to terminate service to the Structure) to prevent further occupancy until the Required Action is completed. The Building Official may also order demolition of the Structure and the City may recover the costs incurred against the Property and the Owner of record.

If the Property owner or other interested party does not take all Required Action or prevail at the hearing, the Construction Regulation Board may impose fines not to exceed \$1000 for each day the violation continues past the date set for compliance and may also enter an order of demolition and assess all costs of the proceedings, in an amount not less than \$600, and the costs of demolition and other required action, for which the City shall have a lien against the Property owner and the Property.

Please govern yourself accordingly.

Involved Other stated his friend, Mr. Guy Junger, is the owner of the house and allows him to stay there. I was unable to make contact with Mr. Junger. Involved Other stated he lives with his girlfriend, Ms. Diana Pulido Johnson. I was able to make contact with Ms. Johnson who was aware Involved Other needed help.

The residence was in poor condition the roof and eaves of the house were collapsing, the backyard was overgrown, and the pool water was green and stagnant. There was a strong pungent odor coming from the inside of the house.

The welfare check was initiated by Code Enforcement Officer, Mrs. Rose Martinez (ID #: 12429), who stated she had been to this location previously to give them violations for the condition of the property.
