 If a school is completing their GOB project - is there an opportunity for getting more from friend's funds????

If the question is, how does an entity funds for a specific renovation/addition not in the GOB, then a contract would need to be developed and negotiated for the terms between the parties.

**2.** If another school comes in under budget, is there a procedure in place to reallocate those funds?

Yes there is process to re-allocate funds. If a project comes under budget, the unused budget gets placed into a central contingency fund to be budgeted to other projects. The unfunded projects are prioritized and the funds allocated by the District's General Obligation Bond Advisory Committee. The Committee is made up of private citizens appointed by the Superintendent and School Board Members.

### SCRC Issues Needing to be Addressed

1. Need to schedule remaining school site walk-thru

We are working on scheduling that walk-thru with schools. We are holding November 1, 2 and 15<sup>th</sup>.

2. Progress report on CGPA walk-thru punch list projects:

Playground- the project design is being finalized next week. Should be able to start the work in November 2016.

3 portables on site. Are those portables being removed? No the portables are needed due to increase enrollment.

Sprinkler system- Additional 6 sprinkler heads were found on the field. The system must be turned on/off manually. No enhancements in the GOB.

Crossing guards- City is working on identifying candidates

Trees on campus – the dead tree in the back were removed and other tree was trimmed.

Double doors to the auditorium need to be restored - not part of the GOB

Painting of the exterior is it part of the GOB- School will be painted once a resolution to the windows are arrived at.

Mold in areas of the school – Roof is being replaced and should address the situation.

Windows – not being installed still waiting for the City's response. We are in the process of "Dispute Resolution" which has statutory steps that need to be taken. Last attempt to obtain a response was September 1, 2016.

# Westlab Expansion Project

1. What is the current status of the Westlab Expansion Project? (I.e. deadline for decision to expand, project timeline, project plan, etc.)

Back in May the discussion came to a stand-still because UM expressed to the City some concerns about the project and Baptist's involvement. After several months, conversations have resumed however.

The district's leadership team met with UM's leadership team at which time UM expressed, for the first time, the possibility of providing funding. The district stressed that *all* parties, including Baptist's parking needs, needed to be addressed in this multi-party agreement.

A subsequent meeting was held on 9/15/16 but funding still remains unsettled. The district has developed other budget scenarios without a parking garage. A meeting has been scheduled with UM for November  $9^{th}$ .

West Lab GOB to be commissioned prior to the end of the school year so all negotiations must be ironed out soon.
