Presentation of a Proclamation declaring October 28, 2009 as Coral Gables: Playful City USA Day

[Note for the Record: Mayor Slesnick prefaced his remarks by stating that the designation of the City of Coral Gables as a "Playful City" is a unique honor, a nationwide recognition that is awarded to only a few cities, and only a handful in the State of Florida; further recalling that during the consideration of the proposed FY 2010 Budget, there was a comment made that when it was announced that Coral Gables was named one of the cities receiving Playful Cities USA designation, that we were chastised for not worrying about the more important things; adding that in his opinion said statement represented a small minded comment; further citing an article from the New York Times, wherein statistical support was given for the direct correlation between exercise and positive health benefits, noting that 4.5 million children have an attention deficit hyperactivity disorder; further pointing out that one hour of vigorous play daily will yield positive health benefits; further stressing that exercise is very important, as it pertains to our kids.

Vice Mayor Kerdyk stated that there have been some significant enhancements being made in connection with Alzheimer's Disease, referencing one event, the Miami Dade Memory Walk; to take place again for the second straight year in Coral Gables and how one can contribute toward ending this disease; further inviting Mr. Enrique Pineiro from the Alzheimer's Association (Southeast Florida Chapter) to join him on the dais regarding the upcoming event, scheduled for November 14th, 2009; further stating that his organization is looking forward to doing its part to end said disease; whereby Mr. Pineiro stated that he was excited about having the Miami-Dade Alzheimer's City Challenge this year, for the second straight year in Coral Gables, noting that last year, there were over 1,000 people participating, and walking the streets of Coral Gables.

Mayor Slesnick stated that he has received a letter of invitation from Mayor Ferreri from the City of Greenacres, to participate in the "Mayoral Challenge" and join other participating employees from other municipalities in Miami-Dade County to come out and defeat Pinecrest Mayor Cindy Lerner during said walk; further noting that the highest percentage of participants from each City will receive a plaque that they will be entitled to hold for 1 year.

Mayor Slesnick noted that it is important to recognize activities, people and events].

[Note for the Record: Port of Miami Director Bill Johnson provided the City Commission with an update on the activities occurring at the Port of Miami; further stating that the Port is the second largest generator for jobs and wealth to our community, thereby generating between \$17 and \$18 billion per year; further noting that the highest paying jobs are in the maritime industry; further noting that Fiscal Year 2009 ended with there being only a slight dip of 2 percent occurring in the cargo sector; wherein most ports across the country are experiencing a dip within a range of approximately 19 to 45 percent; further stating that during the last 10 months, the Port of Miami has not lost a single cargo account; further stating that on the cruise side, the Port of Miami has the largest cruise port; experiencing between five and nine percent growth; further stating that during last fiscal year our rate of growth was flat, with just over 5 million passengers; further pointing out that the Port of Miami, following dredging to a depth of 50 feet, will become only one of three ports in the United States with this depth, thus making it available for expansion into future years, thereby doubling the cargo capacity of the Port of Miami; further informing the Commission that the Port will finish a billion dollar tunnel connecting the tunnel to the Port System, thereby providing for future growth; further stating that the port is also focused on customer service and that it can administratively do the work.

Mayor Slesnick queried Mr. Johnson regarding the availability for community wide tours at said facility, whereby Mr. Johnson stated that the Port of Miami is also the top port in the United States for access and security; Mayor Slesnick further invited Mr. Johnson to do a table top exhibit during our Farmers Market Event].

Mayor Slesnick: Mr. Cabrera.

Commissioner Cabrera: Does anybody have any questions that they want to ask me about this recusal?

Commissioner Withers: Are you going to recuse yourself the next vote?

Commissioner Cabrera: Yes. Did you want me to talk about it any further?

Commissioner Withers: No, no. Ralph listen it's your decision, it's your opinion; obviously the City Attorney doesn't seem to agree with that decision, at least she told me she hasn't, so it's fine.

Mayor Slesnick: I think she summed it up well; the decision-maker has asked whether or not he or she can cast a vote, and I take it from reading Ralph's comments that he doesn't believe he can.

Commissioner Withers: It's not from a financial perspective...

Commissioner Cabrera: Look, I know members of this Commission that have recused themselves on matters that had no financial impact; I know that for a fact; would you like me to give you an example?

Commissioner Withers: Have I ever done it?

Commissioner Cabrera: Not to my knowledge, but I know others that have recused themselves because of matters pertaining to a church they attended or a school...

Commissioner Anderson: Oh wait, no, no; wait a second please....

Commissioner Cabrera: Excuse me ma'am, I'm talking, excuse me ma'am, I'm talking.

People that have recused themselves because of a church and/or a school that they were affiliated with, and there were no financial ramifications there, but no one questioned that recusal.

Commissioner Anderson: Actually...

Commissioner Cabrera: Excuse me ma'am, I'm still talking, I beg your pardon. I listened very quietly as you questioned the City Attorney, I'm sorry you are taking this in such a personal and emotional manner, but I'm simply responding to a fellow colleague. Now, if you'd like me to be quiet, I shall, and I give you the floor ma'am, go ahead.

Commissioner Anderson: No, please go ahead, I'm just asking the City Attorney...

Commissioner Cabrera: You are not allowing me to speak so I might as well allow you to get all excited and emotional, go ahead.

Commissioner Anderson: Well, I'm not going to get all excited and emotional.

Commissioner Cabrera: You just did, I was in the middle of talking to a colleague and you jumped out of your chair, give me a break. To answer your question Chip, I am going to recuse myself again, and I'll tell you why I'm doing it for only one reason, because of my morale compass...

Commissioner Withers: OK.

Commissioner Cabrera:...nothing else...

Commissioner Withers: And Ralph, you know what?- I understand that.

Commissioner Cabrera: And I've never recused myself in eight years and six months on this dais.

Commissioner Withers: And you know, I told you that I understand that and I accept that, its just that I'm a little taken aback that the City Attorney on one side, and I wish she was here...

Commissioner Cabrera: Where is she?

Commissioner Withers: I don't know.

Commissioner Anderson: She went to get my recusal forms for the vote for St. Phillips.

Commissioner Withers: Said that it was to recuse yourself, you need a financial reason to recuse yourself, that's what Liz has told me in the past; and when there is a Jennings violation that by simply admitting the Jennings violation that that removes all conflict, if I'm not correct.

City Attorney Hernandez: It removes all conflict, if the official indicates that they can put aside any bias that they have; it is a presumption that is created when you have an ex parte communication, there are several questions that are asked, and if the official can honestly say that I can put aside any potential bias that I may have received as a result of having the ex parte communication, then they are compelled to vote.

Commissioner Withers: OK - and obviously you can't put aside any type of preconceived judgment on this issue.

Commissioner Cabrera: Because of that conversation that took place.

Commissioner Withers: And if that's your position, then I respect it, I mean, I don't necessarily agree with it, obviously because we disagree, but...you know Ralph, I just think its important that the City and the residents of the City get all of us to weigh in on an opinion...

Commissioner Cabrera: I agree.

Commissioner Withers:...That's why there are five of us.

Commissioner Cabrera: Yes, that's why its so important that in the future instead of somebody just getting up from this dais and taking a walk, that they announce their intent to recuse themselves and do it accordingly, because if that happens again while I'm still here, I'm going to ask the Mayor to hold the proceedings until that person returns and we have a full quorum, because I've seen that happen too; I've seen that happen too in the last eight and-a-half years, and all of a sudden we are making a big issue of my recusal, but that's OK, I'm a big boy, I can handle this, and I can receive it and I can also give it. So I appreciate the fact that you're being so open about it, and I appreciate it.

Commissioner Withers: Like I said, I understand it, I respect your position, I don't necessarily agree with it, but we haven't agreed on things before, so.

Commissioner Anderson: Mr. Mayor, can I speak?

Mayor Slesnick: Mr. Cabrera may I...Ms. Anderson, it's your time.

Commissioner Cabrera: I don't care. Absolutely.

Mayor Slesnick: OK Ms. Anderson.

Commissioner Anderson: I just want to clarify that I did not vote on the St. Phillips Episcopal Church issue because my husband had a business affiliation with the Assistant Head's husband, and for me that was a perception of conflict; I didn't do it because I wasn't a member of the church, that's been accused before, I've heard it before, but I actually - Mr. Ed Miller who was then, who is the husband of Laura Miller, who was the Assistant Head of the school at the time, they had a business relationship, and a filed that as such, and said that on the record. So it was not a question of doing that because I sat through many of our hard decisions, as we all have.

Commissioner Cabrera: Well perhaps what you could have done is openly recused yourself and announced it in such a way so that there would be no doubt in the reasons and the purposes of why you recused yourself.

Commissioner Anderson: I did at the time; you can look through the record.

Commissioner Cabrera: I don't recall the specifics of it, but you know what? - I made a general commentary and you jumped out of your chair, that's your prerogative, you can jump out of your chair any time you want, the point is there was no cause for it, and I'm allowed to be of the same opinion as my colleague to my far left, who doesn't agree with my position. So if we want to get all emotional and hysterical about it, that's fine, that's perfectly OK; we'll return to pre-2009 election. As far as my comments - I'm kind of excited to announce this; for quite some time I have been trying to have some sort of cycling event in Coral Gables, and I've been kind of unsuccessful because of finances and the lack of resources, but I know this is premature and it may not actually come to fruition, but I'm really excited because David Fairchild Tropical Gardens is talking to a group that I am affiliated with to bring a cyclo-cross bicycle race to Coral Gables; and cyclo-cross for those of you that are not familiar with it is a type of bicycle race that incorporates many elements of mountain bicycling with many elements of road racing to bring together a type of bicycle race that is done on grass rather than on road pavement. So right now this group is working with David Fairchild who once again is very excited and has plenty of land, and would welcome this kind of event, and the best thing about it is that the proceeds from the race would go to benefit the American Cancer Society, as well as David Fairchild Tropical Gardens, which I think we need to continue support financially anyway we can. So tentatively this race is being scheduled for January 31st and I hope we can work everything out, and I'll be bringing to the Manager's office some of the elements of the race. So I'm excited about it and I hope it all works out.

Mayor Slesnick: When is this?

Commissioner Cabrera: Well it's tentatively scheduled for January 31st, and so we are hoping that we will be able to make that date. The group is working again with David Fairchild, who's been nothing but supportive and interested in making this happen. So we'll keep you all posted.

Mayor Slesnick: Mr. Kerdyk.

Vice Mayor Kerdyk: Yes, three items. First of all a compliment to the City, the bump-outs on Ponce near the circle are really starting to take flavor and they really are going to be an enhancement to the area there, its going to allow people to access the Fred Hartnett Park there, so I think that's a tremendous asset for our community to have those bump-outs done. I'm going to take the privilege to recognize Ruben Arias who is here from Carlos Gimenez' office, and the reason I'm recognizing you now, not only because you are a great guy, Ruben, but from the standpoint that we are tracking some funds that will be coming in from of the Commission that has to do with parks; apparently you are going to divvy up about five million dollars in funds, and the City has identified a park on Alhambra Circle that was brought to the Commission, and it was really prefaced upon us getting those \$250,000-\$300,000 from the County to add to what we already have to purchase this land. So you can go back there and tell Carlos that we are looking for his support on those funds that would be appreciative. By the way, let me also say, he is always extremely, extremely supportive of Coral Gables, very, very supportive of Coral Gables, Commissioner Gimenez; and the final thing I'd like to mention, this weekend, this past weekend I should say, there was a Gables to the Bay Regatta held, and if you recall there are several residents that set up this Gables to the Bay Regatta including Peter Hairston, Jeff Hicks, many, many residents in the South Gables area; and I'm going to pass out some picture here; there were over 150 participants in this event, and the group of individuals that put it on did an excellent job of informing the neighborhood, and the people on the waterway, that this event was going to be held. Now, this is the first time that I can guarantee you that I can remember ever having an event on the Coral Gables waterway; and I did not receive one complaint; did anybody here receive one complaint?

Commissioner Withers: My phone rang off the hook.

Vice Mayor Kerdyk: Yes, I bet. But if you look at these pictures...

Commissioner Withers: Are these the people that give the free tours?

Vice Mayor Kerdyk: He did a phenomenal job; this is going to the bridges project, and the best thing about this in addition to having 150 people that went through the Gables Waterway, went out to the Bay and then went out to the Shake a Leg, where they had about 300 people in attendance at the overall event; this event raised

\$20,000 to put toward the bridges improvement project. So Peter in that committee should be commended for really holding an event in the City of Coral Gables that was a stand out event, and didn't ring any of our phones. So Peter and everybody congratulations, and to raise \$20,000 in these days and times that's a good event. Thank you.

Commissioner Withers: Now is there any truth that we are going to have Columbus Day in the....(laughter).

Mayor Slesnick: Mr. Withers: Nothing sir.

Mayor Slesnick: You know we voted on a resolution to encourage State Legislature to take action to prohibit texting while driving, and here is...I just opened up the latest edition of the Christian Science Monitor which is one of the most respected news journals in the United States; its gone from a daily newspaper to weekly, and this is a full feature cover article about driving while distracted, and I think it's a very good article for us to look at and read, I mean, we've already suggested to the Legislature what they should do, because of, you know, Mr. Manager I have to tell you, I'm not sure how much conversation has been held since you came or before; I know it happened before you came, but this Commission has expressed several times the concern about our employees using cell phones, hand-held cell phones while driving City equipment, and it's a major cause of injury, a major cause of accidents; and I think that we need to take a look at it, not only in the sense of recommending that civilians don't do it, but also that our City employees don't do it. So I just bring that to you as a background material. We are going to...we are on the verge of adjourning, and moving forward to the circle at Segovia and Coral Way; I hope that we are going to have some County participation, because as everyone should remember the circle at the corner of Segovia and Coral Way was a major project that the City of course conceived and participated in, but it was a project carried off by Miami-Dade County who was a partner with us in many of these things; and because Coral Way is a County road it had to be there's, and since then not only have we had the County Public Works Department participative in building the circle, and we've had our own Public Works Department participating with them in building the circle, we've also had our Public Service Department which has landscaped the circle. It has seemingly, I open this to anybody that wants to say they have heard differently, but seemingly it has been a major facilitator of traffic at that intersection, and to me many of the people in the buildings around it have said how much quieter traffic is because of fewer horns, and fewer screeching, and fewer accidents, and so forth. With that we are going to do down and commemorate its opening. Mr. Manager is there any instructions so that...Mr. Manager, any instructions about what we are doing there? We are going; I guess we can walk down together.

City Manager Salerno: Walk down there, very brief ceremony Mayor and

ribbon-cutting.

Mayor Slesnick: Ribbon-cutting - very good. I will see everyone there; everyone listening to this is invited to join us and we will see you at the circle. We will adjourn. Thank you.
