

**RESOLUTION NO. 2025-**

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA AMENDING ORDINANCE NO. 2015-17, AS AMENDED, TO ADD AND AMEND FEES BY THE DEVELOPMENT SERVICES DEPARTMENT AND THE COMMUNITY RECREATION DEPARTMENT; PROVIDING FOR SEVERABILITY, AND AN EFFECTIVE DATE.

**WHEREAS**, the City Commission has determined that fees for various licenses, permits, camps, tournaments, and services are necessary to recover the City's cost of providing these services; and

**WHEREAS**, the Development Services department recommends amendments to simplify the Certificate of Use fee structure to align renewal periods with the City's Business Tax Receipt renewal cycle; and

**WHEREAS**, the Certificate of Use and Business Tax Receipt renewals will now occur concurrently, with all renewal payments due annually by September 30; and

**WHEREAS**, these adjustments will improve administrative efficiency, simplify the renewal process for businesses, and provide a more streamlined customer experience; and

**WHEREAS**, the Community Recreation department recommends amending the Summer Camp fees for Youth Center Summer Camps and Tennis Summer Camps to account for increased costs associated with operating the programs through overall summer camp fee increases; and

**WHEREAS**, the adjustments to the Community Recreation department fees will help offset rising expenses related to staffing, supplies, equipment, and facility operations, while allowing the department to continue providing high-quality summer camp programs and services to the community; and

**WHEREAS**, the adjustment to the fees includes the addition of structured tournament fees based on the tournament's participant size, a revised school program fee, and a correction to the fee breakdown for the High Performance Camp fees to properly align with the established two-hour pricing structure.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission revises the Fee Schedule as detailed in Exhibit I, with changes indicated by underline for new text and ~~striketrough~~ for deleted text.

**SECTION 3.** If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

**SECTION 4.** That said Resolution shall become effective upon the date of its passage and adoption herein.
