RESOLUTION NO. 2023-75

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA, DIRECTING THE CITY MANAGER TO WORK WITH STAFF TO REPLACE ALL DAMAGED, MISSING, AND OUTDATED STREET SIGNS IN PHASES, BEGINNING WITH THE CENTRAL BUSINESS DISTRICT, FOLLOWED BY MIRACLE MILE AND PONCE DE LEON.

WHEREAS, prior to the COVID-19 Pandemic the City approved a master plan for wayfinding and signage throughout the City which was inevitably put on hold due to unforeseen circumstances of the pandemic; and

WHEREAS, irrespective of such unforeseen circumstances, City staff proceeded to execute several ad hoc improvements which include the replacement of all outdated blue and white signs in the City's residential zones with decorative signs and posts better aligned with City standards; and

WHEREAS, to date, city staff has replaced antiquated signage at all City Trolley stops resulting in the replacement of over 300 signs; and

WHEREAS, the City Commission desires for City-wide signage to be consistent and in alignment with City Code and beautification standards; and

WHEREAS, it is the will of the City Commission for this project to be executed in phases, commencing with the replacement of outdated, damaged or missing signs and posts in the Central Business District, followed by outdated, damaged, or missing signs and posts on Miracle Mile and Ponce De Leon Blvd.;

NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission hereby directs the City Manager to work with staff to move forward and replace all missing, damaged, and outdated street signage and posts in the City through a phased approach beginning in the Central Business District, followed by Miracle Mile and Ponce de Leon, and then the rest of the City.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
