

**AMENDMENT NO. 1  
TO AGREEMENT NO. C2102  
BETWEEN  
FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION  
AND  
CITY OF CORAL GABLES**

This Amendment to Agreement No. C2102 (Agreement) is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and City of Coral Gables, 405 Biltmore Way Coral Gables, Florida 33134 (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for Coral Gables Waterway / Biscayne Bay Water Quality Improvements effective October 2, 2023;

WHEREAS, the parties wish to amend the Agreement as set forth hereinto extend the agreement period.

NOW THEREFORE, the parties agree as follows:

- 1) The Agreement is extended for a fifteen-month period to begin July 1, 2024, and remain in effect until September 30, 2025. The Department and the Grantee shall continue to perform their respective duties during this extension period pursuant to the same terms and conditions provided in the Agreement.
- 2) Attachment 1, Standard Terms and Conditions (Rev. 11/14/2022), is hereby deleted in its entirety and replaced with Attachment 1, Standard Terms and Conditions (Rev. 9/15/2023), as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 1 shall hereinafter refer to Attachment 1, Standard Terms and Conditions (Rev. 9/15/2023).
- 3) Attachment 2, Special Terms and Conditions (Rev. 10/12/2022), is hereby deleted in its entirety and replaced with Attachment 2, Special Terms and Conditions (Rev. 8/8/2023), as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 2 shall hereinafter refer to Attachment 2, Special Terms and Conditions (Rev. 8/8/2023).
- 4) Attachment 3, Grant Work Plan, is hereby deleted in its entirety and replaced with Attachment 3-A, Revised Grant Work Plan, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 3 shall hereinafter refer to Attachment 3-A, Revised Grant Work Plan.
- 5) Exhibit A, Progress Report Form, is hereby deleted in its entirety and replaced with Attachment A-1, Progress Report and Deliverable Submission Form, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment A shall hereinafter refer to Attachment A-1, Progress Report and Deliverable Submission Form.
- 6) Exhibit C, Payment Request Summary Form, is hereby deleted in its entirety and replaced with Exhibit C-1, Revised Payment Request Summary Form, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment C shall hereinafter refer to Exhibit C-1, Revised Payment Request Summary Form.
- 7) All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistencies may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.
