RESOLUTION NO. 2009-283

A RESOLUTION AUTHORIZING THE EXTENSION OF A CONTRACT WITH GENUINE PARTS COMPANY, D/B/A NAPA AUTO PARTS PURSUANT TO SECTION 2-834 (D) OF THE PROCUREMENT CODE ON A MONTH TO MONTH AS NEEDED BASIS UNTIL SUCH TIME AS A NEW CONTRACT IS APPROVED OR A NEW VEHICLE PARTS STRATEGY IS IMPLEMENTED.

WHEREAS, on October 1, 2003, the City entered into a piggyback contract with Genuine Parts Company, d/b/a as NAPA Auto Parts for the provision of vehicle parts; and

WHEREAS, the contract provided for an initial two (2) year term with an option to renew for two (2) additional two (2) year terms with the last term expiring October 1, 2009; and

WHEREAS, under Section 2-834 (d) of the Procurement Code, this contract with Genuine Parts Company, d/b/a NAPA Auto Parts should be extended on a month to month as needed basis until such time as a new contract is approved or a new vehicle parts strategy is implemented; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to extend the contract of Genuine Parts Company, D/B/A NAPA Auto Parts pursuant to Section 2-834 (d) on a month to month as needed basis until such time as a new contract is approved or a new vehicle parts strategy is implemented.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
