RESOLUTION NO. 2026-23

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2025-2026 ANNUAL BUDGET TO INCREASE THE TRAVEL EXPENSE BUDGET IN OFFICE OF THE CITY COMMISSION AND TO RECOGNIZE A TRANSFER OF \$16,500 FROM THE GENERAL FUND AND TO APPROPRIATE SUCH FUNDS FOR TRAVEL COSTS.

WHEREAS, there is a need to increase the travel expense budget for the cost of travel to support legislative initiatives and other approved city business; and

WHEREAS, the Commission desires to amend the adopted travel expense budget of \$6,600; \$1,800 for the Mayor and \$1,200 for each of the four Commissioners to \$16,500; \$4,500 for the Mayor and \$3,000 for each of the four Commissioners; and

WHEREAS, an amendment to the Fiscal Year 2025-2026 annual budget is required to increase the travel expense budget in Office of the City Commission and to recognize a transfer of \$16,500 from the general fund and to appropriate such funds for travel costs;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. the Commission desires to amend the adopted travel expense budget of \$6,600; \$1,800 for the Mayor and \$1,200 for each of the four Commissioners to \$16,500; \$4,500 for the Mayor and \$3,000 for each of the four Commissioners.

SECTION 3. Fiscal Year 2025-2026 annual budget is required to increase the travel expense budget in Office of the City Commission and to recognize a transfer of \$16,500 from the general fund and to appropriate such funds for travel costs.

SECTION 4. That this Resolution shall become effective on the date of its passage and adoption herein.


