RESOLUTION OF THE CITY COMMISSION Α ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO AUTHORIZE PURCHASE OF THE TAC HOUSE SIMULATION TRAINING SYSTEM FROM "SOLE ACTION TARGET AS Α **SOURCE** PROCUREMENT," PURSUANT TO SECTION 2-689 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the Police Department has determined a need to purchase a modular tactical house simulation system to be used by its Training unit; and

WHEREAS, the equipment associated with this program provides the Police Department with essential Public Safety training capabilities; and

WHEREAS, the cost for the purchase of this equipment totals \$82,800.00; and

WHEREAS, the Police Department evaluated equipment from multiple vendors and concluded that the specific equipment from Action Target is the equipment that best fits their needs; and

WHEREAS, Action Target is the patent holder and sole provider of the selected equipment; and

WHEREAS, Section 2-689 of the Procurement Code, entitled "Sole Source Procurement" authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on awards:

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation and authorizes the City Manager to authorize the Police Department to purchase a TAC House Simulation Training System from Action Target in the amount of \$82,800.00, pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
