Commissioner Lara: Thank you and welcome.

Ms. Jorges: Thank you. So, as you may remember, on February 11, 2025, the City Commission adopted a resolution 2025-28, which directed staff to implement a pilot program, offering registered city residents a 25 percent discount for hourly rate street parking municipal lots and certain city owned parking garages. The program is scheduled to end on July 6<sup>th</sup>, but this resolution proposes extending the pilot through the date of the first Commission meeting in January 2026. This will allow staff to further collect additional data and analyze the impact of reduced parking rates for the city.

Commissioner Castro: Thank you for presenting it.

Ms. Jorges: Thank you. Thank you for your time.

Mayor Lago: Thank you. Commissioner.

Commissioner Castro: Monica, do you have anything to add to this item, to this resolution.

Parking Director Beltran: Monica Beltran, Director for Parking Sustainability and Mobility Services. So, I am happy to report that the program continues to grow. The waived revenue is very manageable. We now have 1,400 tags registered and I received positive comments about the program.

Mayor Lago: How much is it costing the city?

Parking Director Beltran: Its less than one percent. It's about 85 cents per transaction. It's a very minimal waiving of revenue.

Mayor Lago: And having changed the way that we accept funds, the credit card funds, does this become a net neutral when you reduce the 25 percent and you add the credit card fee on top of it, what does that equal to the resident?

Parking Director Beltran: Actually, because we now waive transaction fees per credit card transaction through mobile payments, such as pay-by-phone and soon park mobile, with the new

contract we waive the transaction fee which is 35 cents, and the credit card fee is 25. So actually, that more than neutralizes, it actually helps residents. So, this is separate and apart from...

Mayor Lago: So, there is no credit card fee anymore – zero.

Parking Director Beltran: The credit card fee exists, but it's 25 cents and the transaction fee when you use the mobile system, like pay-by-phone, which is 35 cents, is being waived for all residents. That's just part of the contract that we negotiated.

Mayor Lago: Alright. Anything else for the good of the order.

Commissioner Castro: I'll move it.

Vice Mayor Anderson: I'll second.

Mayor Lago: Okay.

City Clerk Urquia: Mr. Mayor, I have a member of the public requesting to speak on the item, Mrs. Maria Cruz.

Mrs. Cruz: Mrs. Maria Cruz, 1447 Miller Road. I guess I'm going to surprise the Mayor because I think this is very good what I hear. I haven't registered my car because usually my daughter drives and she doesn't live in the city and I didn't want to commit fraud and have her drive my car, so when she drives she pays the parking, but I have heard from so many people that said that they used to avoid coming downtown, coming to Miracle Mile and to restaurants here and this is an incentive. They are so happy that this is in place. As a matter of fact, the other day we had a meeting at church and there were three ladies that asked me, how do I go about it. I said, "I don't know, you go online or call Monica, and she'll tell you what to do. It is one of the things that we have done that people are very happy with.
