Said election was conducted in order to fill one (1) vacancy on the City of Coral Gables Retirement Board. The election was duly held and a total of three (3) ballot boxes were located at the following herein below referenced locations:

- A. Police/Fire Department, Main Lobby, 2801 Salzedo Street
- B. Public Works Department, Main Lobby, 2800 S.W. 72<sup>nd</sup> Avenue
- C. Office of the City Clerk, 405 Biltmore Way

I) Three (3) individuals qualified as candidates for Retirement Board Election for Participating Full-Time Employee seat. Said three (3) candidates' names were placed on the ballot.

II) A total of ballots of 544 were cast in said election. A total of 527 ballot(s) were counted. A total of 17 ballot(s) were voided.

III) Voters were allowed to vote for one (1) candidate of their choice.

IV) We further certify and declare that the results of the City of Coral Gables Retirement Board Election, for the Participating Regular Full-time Employee Representative seat, which was held December 1<sup>st</sup>, through December 4<sup>th</sup>, 2009, are as follows:

V) Following the closure of the qualifying period, December 4, 2009, there was only one nomination petition filed for the Participating Police Officer Representative seat, namely incumbent Agustin Diaz (incumbent), who ran unopposed.
