RESOLUTION NO. 2010-229

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER FOR THE PURCHASE OF A PRE-OWNED 2007 BUCKET TRUCK (TEREX AERIAL DEVISE INSTALLED ON A INTERNATIONAL TRUCK CHASSIS) AS A “SOLE SOURCE” FROM RING POWER CORPORATION OF ST. AUGUSTINE, FLORIDA IN THE AMOUNT OF \$62,500.00 (SIXTY-TWO THOUSAND FIVE HUNDRED DOLLARS), PURSUANT TO SECTION 2-770 OF THE CITY’S PROCUREMENT CODE AND FURTHER AUTHORIZING THE EXECUTION OF THE CONTRACT.

WHEREAS, under Section 2-770 of the Procurement Code, entitled “*Sole Source Procurement*” a contract may be awarded without competitive bids when the contract by its very nature is not suitable to competitive bids or proposals, as there is only one source (sole source) for this pre-owned bucket truck; and

WHEREAS, Section 2-650 of the Procurement Code, entitled “*Authority*” authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, that an appropriation of funds is hereby authorized for the pre-owned 2007 bucket truck from the Automotive Fund in the amount of \$62,500.00 (sixty-two thousand, five hundred dollars);

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the recommendation of the Chief Procurement Officer to purchase a pre-owned 2007 bucket truck (Terex aerial devise installed on a International truck chassis) from Ring Power Corporation of St. Augustine, Florida, the sole source vendor, in the amount of \$62,500.00 (sixty-two thousand, five hundred dollars), pursuant to Section 2-770 of the Procurement Code entitled “*Sole Source Procurement*.”

SECTION 3. That an appropriation of funds is hereby authorized for the pre-owned 2007 bucket truck from the Automotive Fund in the amount of \$62,500.00 (sixty-two thousand, five hundred dollars).

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
