**RESOLUTION NO. 2024-156**

A RESOLUTION OF THE CITY COMMISSION AMENDING THE BUDGET TO FUND THE INSTALLATION OF TEMPORARY SPEED TABLES AT ALL LOCATIONS PENDING TRAFFIC CALMING IMPROVEMENTS.

**WHEREAS**, the City of Coral Gables is dedicated to improving the accessibility and quality of life of our neighborhoods through safer streets; and

**WHEREAS**, pursuant to an Intergovernmental Agency Agreement between Miami-Dade County and the City of Coral Gables, the City assumed the installation and maintenance responsibilities of certain traffic calming devices on certain local municipal streets; and

**WHEREAS**, the City's Public Works Department has been implementing the City's traffic calming initiative by determining whether certain local municipal streets qualify for traffic calming, designing the installation of certain traffic calming devices, ascertaining whether there is concurrency of residents in the affected neighborhoods, and upon design and determination of concurrency, constructing the approved traffic calming devices; and

**WHEREAS**, there are currently eight (8) locations that are slated for construction of traffic calming devices after determination of concurrency and an additional fifty-two (52) locations in the City where traffic calming devices have requested and meet the criteria for installation of traffic calming devices, but the design phase and concurrency determination have not yet been completed; and

**WHEREAS**, given the timeline for design, balloting, and construction of traffic calming devices at all the pending locations, the City Commission wishes to install temporary speed tables at all such locations; and

**WHEREAS**, the City Commission wishes to amend the budget to recognize as revenue \$165,0000 in mobility impact fees and to appropriate the funds to be used for the purchase and installation of thirty (30) temporary speed tables;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission wishes to amend the budget to recognize as revenue \$165,0000 in mobility impact fees and to appropriate the funds to be used for the purchase and installation of thirty (30) temporary speed tables.

**SECTION 3.** To the extent necessary, the City Commission waives any procurement requirements related to the purchase or installation of these temporary speed tables and authorizes the City Manager execute any necessary bid waivers.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.


