Procurement Officer Walker: Good afternoon, Celeste Walker, Chief Procurement Officer. This is a competitive solicitation that was issued for construction. Nine bidders responded and we are awarding to the most responsive bidder. So, we'd like to move this item forward.

Vice Mayor Lago: Can I ask you a quick question?

Procurement Officer Walker: Yes.

Vice Mayor Lago: First, I want to congratulate you and your team on this work. I think it went off without a hitch. I think it was very well done.

Procurement Officer Walker: Thank you.

Vice Mayor Lago: It brought me great satisfaction to see nine bidders engaged, its great, because I think that that shows value for the community and that shows that, obviously, we are doing everything that we possibly can to get as many people enticed. I know it's a pretty significant project. We are not talking about the Public Safety Building, but we are still talking about a few million dollars.

Procurement Officer Walker: Correct.

Vice Mayor Lago: Its an important job. We've been waiting for a long time and I think its going to go well hand-in-hand with, obviously, what we are trying to do here in City Hall and the restoration of City Hall. I know that we are doing the roof and a bunch of different things forthcoming to make sure that we bring this building back to its grand splendor. So, I just wanted to commend you.

Procurement Officer Walker: Thank you.

Vice Mayor Lago: To take the time, because I think that a lot of times we always try to nitpick on certain things, but the fact that we got nine people to bid in this economy, and I want to make sure people understand, there is so much work on the street, in construction work and design work right now, that its very hard to get people to come out and bid on these jobs. So, I wanted to commend you on that. I've dealt with Carivon before, I don't know them personally, but I've dealt with them. I've competed with them years ago in the School Board, good company, good outfit. They do good work.

Procurement Officer Walker: The legal review was fine. There were no issues as far as litigation was concerned.

Vice Mayor Lago: Good. The time schedule for completion?

Procurement Officer Walker: I think its 150 days. Let me make sure. That's aggressive.

Vice Mayor Lago: That's a pretty aggressive timeline. Very good.

Mayor Valdes-Fauli: That's something we desperately need.

Vice Mayor Lago: Desperately – you're 100 percent right Mayor. I just wanted to make sure to give staff the credit they deserve, because number one, I think the timeframe, I read it in the documents, just wanted to confirm that I had read the correct number, because for a project of this scale, to get it done in five months is pretty significant; and also, I think it's a great project and I look forward to its completion.

City Manager Iglesias: And Vice Mayor the plans have been permitted, gone through DERM, and ready to go.

Vice Mayor Lago: Yes, I know you worked on that with your team very hard to get that taken care of, so we can just be seamless on that front. So, congratulations on that.
