## **RESOLUTION NO. 2015-**

A RESOLUTION AUTHORIZING ACCEPTANCE OF A DONATION OF A DESIGN FOR A SCULPTURE BY ARTIST LUIS FERNANDEZ, LOCALLY KNOWN AS LUGUFELO, AT THE TRAFFIC CIRCLE AT RED ROAD AND LUGO AVENUE; THAT THE WORK BE FULLY FUNDED BY THE RESIDENTS OF GABLES BY THE SEA, INCLUDING MAINTENANCE; THAT THE PREFERRED COLOR BE ORANGE OR RED; AND THAT THE BASE BE SUBMERGED INTO THE LANDSCAPE.

**WHEREAS**, Luis Fernandez, locally known as Lugufelo, (the "Artist") has generously offered to donate a design and his fabricator is willing to donate services; and

**WHEREAS,** a recommendation to accept the donation was approved by the Arts Advisory Panel on March 17, 2015; and by the Cultural Development Board on April 22, 2015; and

**WHEREAS,** a recommendation to accept the proposal by the Gables by the Sea residents to place the sculpture at the entry of Red Road and Lugo Avenue; and that the work be fully funded by the residents including maintenance; and that the preferred color be orange or red; and that the base be submerged into the landscape was approved by the Arts Advisory Panel on March 17, 2015; and by the Cultural Development Board on April 22, 2015.

WHEREAS, it is subject to Miami Dade County approval.

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

- **SECTION 1**. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.
- **SECTION 2.** That the City Commission does hereby authorize accepting the Artist donation.
- **SECTION 3.** That this resolution shall become effective immediately upon the date of its passage and adoption herein.
