A. CALL TO ORDER

C. APPROVAL OF THE MINUTES

Mr. Valdes-Fauli made a motion, and Ms. Burgos seconded, to approve the minutes of the December 19, 2023, meeting, which passed unanimously.

D. <u>NEW BUSINESS</u>

D.-1. "Dear Human" – temporary public art project

Board Members were provided with information about "Dear Human", a poetry-based based temporary public art activation celebrating National Poetry Month in April in partnership with O, Miami and the Lowe Art Museum, with a funding recommendation up to \$10,000 from the Art Fund.

A motion was made by Mr. Corral, and seconded by Ms. Burgos, to recommend support of "Dear Human" in partnership with O, Miami and the University of Miami's Lowe Art Museum, which passed unanimously.

D.-2. Environmental Project Discussion – Xavier Cortada

Board members discussed a request through the City Manager from Vice-Mayor Anderson to consider commissioning a public art piece that addresses environmental issues, especially related to native plants. Members were advised of the Vice-Mayor's interest in discussing this opportunity with artist Xavier Cortada. After discussion, board members agreed they would like a recommendation from the Arts Advisory Panel and consider accepting proposals from more artists.

A motion was made by Mr. Valdes-Fauli, and seconded by Mr. Corral, to have a recommendation from the Arts Advisory Panel regarding development of an RFP for public art addressing environmental issues, which passed unanimously.
