[Note for the Record: Following Mayor Valdes-Fauli’s reading of the title to Agenda Item 1 (i.e. Congratulations to Officer Robert Wright, recipient of the City of Coral Gables “Officer of the Month Award,” for the month of June, 2017), Mayor Valdez-Fauli asked Police Chief Hudak to present the “Officer of the Month” for June 2017. Chief Hudak stated it is a pleasure to recognize the great efforts of our officers and asked Acting Major Brian Lawrence to introduce the “Officer of the Month” for June.

Acting Major Lawrence stated that on June 26, 2017, at 6:53 p.m., Officer Wright along with Officers Johnson and Delgado were dispatched to 9345 Balada Street to a burglary in progress, wherein an unknown male subject was inside a residence. Acting Major Lawrence further stated upon arrival, Officers made contact with the housekeeper, who stated that she observed an unknown male in the residence, whereupon the male subject ran outside through a sliding door to the backyard. Acting Major Lawrence said that Officers Wright and Johnson proceeded to check the area finding the unknown subject hiding in bushes and apprehending him just three houses south from where the burglary took place. Acting Major Lawrence added the victim was taken to the scene of the apprehension and was able to identify the unknown subject as the burglar. Acting Major Lawrence stated that as a result of Officer Wright’s determination the offender was captured.

Officer Wright thanked the City Commission, City Manager Swanson-Rivenbark and the Police Chief Hudak for being selected as “Officer of the Month” for June, 2017].

Fire Chief de la Rosa stated that Battalion Chief Carla Rossby has been selected July’s “Firefighter of the Month” for her meritorious display of job performance, specifically for her exceptional actions during a structural fire in a multi-family apartment building. Fire Chief de la Rosa stated that initial reports by firefighters inside the involved apartment were that the fire had extended into the attic, threatening the entire building. Fire Chief de la Rosa stated that Chief Rossby immediately called for an offensive attack, which included ventilation of the roof. Fire Chief de la Rosa said Chief Rossby’s command and control of the incident prevented loss of life, injuries, and the total loss of the building and the homes of 9 families. Chief de la Rosa stated that Chief Rossby’s knowledge and experience paid off once again and added that she is a very consistent and reliable, and very deserving of this award.

Battalion Chief Carla Rossby thanked the City Commission, City Manager Swanson-Rivenbark and Chief de la Rosa for her selection as the “Firefighter of the Month Award”].

[Note for the Record: Following Mayor Valdes-Fauli’s reading of the title to Agenda Item 3 (i.e. Congratulations to the Coral Gables Fire Department Rescue crew, recognized for an outstanding lifesaving response to a medical emergency involving a female patient in cardiac arrest). Mayor Valdes-Fauli’s asked Chief de la Rosa to introduce the members of the Rescue 1 crew.

Chief de la Rosa stated that on September 30, 2016, Rescue 1 (Lt. Joseph

Fantigrassi, Driver Timothy McAlister, and Paramedic Eric Cos) responded to a 9-1-1 call at 3306 Ponce de Leon Boulevard. Chief de la Rosa stated upon arrival of the crew, Coral Gables Police Officers were already performing CPR on a nonresponsive 42-year old female, who was described by witnesses as possibly having a seizure. Chief de la Rosa stated that the initial assessment by the crew revealed the patient was not breathing, with no pulse and was in cardiac arrest, adding that the patient was clinically dead. Chief de la Rosa stated that the Rescue 1 crew shocked the patient, intubated her, established intravenous (IV) access and administered an anti-dysrhythmic drug to stabilize her heart rhythm. Chief de la Rosa stated that by the time the patient was transported to Coral Gables Hospital, she had regained a pulse with a blood pressure, but still remained unresponsive. Chief de la Rosa stated that all things came together to have a significant impact on someone's life, and that in itself is a career achievement. Chief de la Rosa said this favorable outcome was absolutely made possible by the caring, professionalism, and teamwork put forth by our Fire Rescue crew and the Police Officers who initially responded that had a direct impact in saving a life. Chief de la Rosa said that everything is about teamwork from the City Commission and City Manager's Office who afford us the resources and equipment that we need to make an impact, to the 911 staff, the police officers, fire rescue crews, and the hospital; all of that came together, so everyone who had a part should feel just as excited and happy that we are able to introduce Mrs. O'Reilly.

Ms. O'Reilly stated that this is the tough part as she doesn't remember what happened like everyone else. Mrs. O'Reilly said that she wanted to say thank you to these guys, as clearly she would not be here without them. Mrs. O'Reilly also thanked the 9-1-1 staff, the Police Officers who initially responded to help her and the Hospital staff at Coral Gables Hospital].
