RESOLUTION AUTHORIZING THE EXECUTION OF ADDENDUM NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT FOR DISASTER DEBRIS SERVICES WITH THE PRIMARY CONTRACTOR, ASHBRITT, INC., FOR THE PURPOSE OF PROVIDING ADDITIONAL BONDING REQUIREMENTS AND FURTHER AUTHORIZING EXECUTION OF SUBSEQUENT PROFESSIONAL SERVICES AGREEMENTS WITH THE SECONDARY OR BACKUP CONTRACTORS, CERES ENVIRONMENTAL AND JB COXWELL DISASTER RECOVERY, INCLUSIVE OF THE SAME LANGUAGE AS THE ASHBRITT, INC., AGREEMENT AND ADDENDUM NO. 1.

WHEREAS, Resolution #2009-61 (As Amended) authorized professional services agreements for disaster debris management services with Ashbritt, Inc., as the primary contractor and Ceres Environmental and JB Coxwell Disaster Recovery as secondary or backup contractors; and

WHEREAS, the CITY requires PROFESSIONALS to post a Performance Payment Bond and a Labor & Material Payment Bond of \$15,000,000.00 from a Corporate Surety satisfactory to the City per project, as security for the performance of work and prompt payment to all persons supplying labor and materials in the execution of work to be performed under the AGREEMENT; and

WHEREAS, the CITY, for further security, requires PROFESSIONAL to maintain a Performance Bond and a Labor & Material Payment Bond from a Corporate Surety satisfactory to the CITY throughout the entire term of the AGREEMENT in a sum equal to One Million Dollars (\$1,000,000.00); and

WHEREAS, Ashbritt, Inc. has agreed to the additional bonding requirements without objection.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That execution of the attached Addendum No. 1 with Ashbritt, Inc. is authorized and shall be made a part of this Resolution with the executed Professional Services Agreement.

SECTION 3. That execution of subsequent professional services agreements with Ceres Environmental and JB Coxwell Disaster Recovery, inclusive of the same language as the Ashbritt Inc. Agreement and Addendum No. 1, are hereby authorized.

SECTION 4. That this resolution shall become effective upon the date of its adoption herein.
