**RESOLUTION NO. 2024-93**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING ACCEPTANCE OF AN AMENDMENT FOR GRANT AGREEMENT NO. 23h.sc.900.154 FROM THE STATE OF FLORIDA, DEPARTMENT OF STATE (DOS), DIVISION OF HISTORIAL RESOURCES FOR A SIX MONTH EXTENSION FROM JUNE 30, 2024 TO DECEMBER 31, 2024 TO THE AGREEMENT FOR THE RESTORATION OF THE HISTORIC GONDOLA BUILDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT OF THE AGREEMENT WITH DOS FOR SAID FINANCIAL ASSISTANCE UNDER AGREEMENT NO. 23h.sc.900.154, FOR FINANCIAL SERVICES.

**WHEREAS**, the appropriation and authorization for the City Manager to execute the grant agreement was part of the FY23 Budget with Resolution 2023-164. The competitive grant was awarded from the State of Florida, Department of State (DOS), Division of Historical Resources for the Restoration/Reconstruction of the Historic Gondola Building in the amount of \$750,000. The project consists of restoring the building using historical documentation and salvageable elements from the original building; and

**WHEREAS**, an amendment to the agreement has been made for a six month extension from June 30, 2024 to December 31, 2024; and

**WHEREAS**, the amendment does not have any negative impact to the city's grant award with DOS; and

**WHEREAS**, the total project cost is \$1,500,000 of which \$750,000 is from the grant and \$750,000 is the required matching funds from the City of Coral Gables; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby authorize the acceptance of an amendment for an extension to the Agreement to the State of Florida, Department of State, Division of Historical Resource grant in the amount of \$750,000 for the Restoration of the Historic Gondola Building with DOS Agreement No. 23h.sc.900.154.

**SECTION 3.** That the City Manager executes the amendment for an extension to the DOS Agreement No. 23h.sc.900.154.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.




