This cause having come before the Code Enforcement Board for Hearing on 9/15/2021, and based on the evidence, the Board enters the following FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER:

FINDINGS OF FACT

The Respondent is the property owner and is subject to Section 101-107. The Respondent is in violation of:

Violations:

- Zoning Code - Article 3, section 3-208. Interior construction, alterations, and/or repairs without necessary approval and permit(s).
City Code - Chapter 105, section 105-26, F.B.C. - section 105.1. Work done without a permit.
- PERFORMED INTERIOR WORK WITHOUT APPROVAL OR PERMITS

CONCLUSIONS OF LAW

1. The Respondent(s) shall pay administrative costs of \$108.75.
2. The Respondent(s) shall correct the violation/s. Respondent(s) shall comply in 30 days by 10-15-2021 to submit for permit.
3. If the violation(s) are not corrected by 10/15/2021, a fine of \$150.00 will be imposed for each day thereafter that any violation continues to exist.
4. If the Respondent(s) does (do) not comply within the time specified, a certified copy of this Order shall be recorded in the Public Records of Miami-Dade County and thereafter SHALL CONSTITUTE A LIEN against the property upon which the violation(s) exist or upon any real and personal property of the violator.

The foregoing findings of fact constitute a violation of the listed sections of the Code of the City of Coral Gables. It is the Order of this Board, based upon the foregoing:
