RESOLUTION NO. 2024-

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING ACCEPTANCE OF AN AMENDMENT FOR GRANT AGREEMENT NO. 4486-098-R, PHASE I FROM THE STATE OF FLORIDA DIVISION OF EMERGENCY MANAGEMENT (FDEM) IN THE AMOUNT OF \$144,764, FOR THE EXTENSION OF THE EXPIRATION DATE FOR THE DOWNTOWN CORAL GABLES DRAINAGE AND WATER QUALITY IMPROVEMENTS PROJECT TO MAY 31, 2025 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT OF THE AGREEMENT WITH FDEM FOR SAID FINANCIAL ASSISTANCE;

WHEREAS, on May 9, 2023, the City Commission accepted a competitive grant award from the State of Florida Division of Emergency Management (FDEM) for the Coral Gables Drainage and Water Quality Improvements Project, Phase I in the amount of \$144,764 to improve drainage infrastructure to alleviate or significantly improve potential flooding during and immediately following major storm events; and

WHEREAS, an amendment to the agreement has been made for the extension of the expiration date from May 31, 2024, to May 31, 2025; and

WHEREAS, the extension does not have any negative impact to the city's grant award with FDEM and

WHEREAS, upon completion of Phase I of the project, the Florida Division of Emergency Management agreed to provide financial assistance for Phase I in the amount of \$144,764, representing 90% of the construction phase's cost to implement the design phase and the City's contribution will be 10% for a total of \$15, 273; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby authorize the acceptance of an amendment for the extension of the agreement to the Florida Division of Emergency

Management grant in the amount of \$144,764 for the Downtown Coral Gables Drainage and Water Quality Improvements Project with FDEM Agreement No. 4486-098-R.

SECTION 3. That the City Manager is authorized to execute the amendment to extend the expiration date from May 31, 2024, to May 31, 2025 for FDEM Agreement No. 4486-098-R.

SECTION 4. That this resolution shall become effective upon the date of its passage and adoption herein.
