## A RESOLUTION OF THE CITY COMMISSION TO APPROVE THE CITY OF CORAL GABLES ECONOMIC DEVELOPMENT STRATEGIC PLAN. (12.4.24 EDB RECOMMENDED APPROVAL, VOTE 5-0).

**WHEREAS**, the Coral Gables Comprehensive Plan's Future Land Use Element and the strategies outlined in the Plan align with similar goals, objectives, and policies to create more economically viable and livable districts; and

**WHEREAS**, after notice of a public meeting before the Economic Development Board which was held on December 4, 2024, the Board recommended approval (vote: 5-0) of the Plan; and

**WHEREAS**, the City Commission believes that the implementation of the Plan will provide a roadmap for realistic, sustainable and resilient economic growth and development in Coral Gables, ensuring its continued success as a premier destination for businesses, residents, and visitors alike;
