Staff Liaison Zeida Sardinas provided the Board with a copy of the Rent Report and informed the Board of the inclusion of the renewal column, as requested at the November 16th meeting. Ms. Sardinas explained some of the language used in the column and clarified the renewal terms of some of the properties listed. Board Members reviewed the Rent Report, and Ms. Sardinas addressed questions as they arose.

Staff Liaison Zeida Sardinas updated the Board on the sale of the Doctors Hospital Lot, summarized the history of the sale and informed the Board of improvements planned for the lot. Additionally, Ms. Sardinas informed the Board of the subsequent lease of the right of way until the completion of the improvements.

#### 4 OTHER BUSINESS

The Board discussed the role of the Property Advisory Board within the City, as well as term lengths and limits.

Board Member Maderal inquired about the unsolicited bid for the property at 477 South Dixie Hwy mentioned in the November 14th meeting minutes. Ms. Sardinas addressed the question by briefly summarizing the history of the unsolicited bids for said property. Board Member Maderal further inquired about new unsolicited bids, for which Ms. Sardinas informed the Board that the City had not received new unsolicited bids.

Board Members discussed the categorization of City-owned properties. Ms. Sardinas will circulate a list of all City-owned properties for the Board Members' review and discussion at a future meeting, along with a copy of the 2021-2022 Property Advisory Board Annual Report for the Board's review.

Ms. Sardinas informed the Board of an item presented at the December 13th Commission Meeting regarding location ventures.

Board Member Mazzei Anderhub requested an update on the remediation work at Coral Gables Museum. Ms. Sardinas updated the Board by stating that the City has conducted an internal inspection of the property as well as contracted an external inspector. The City will formulate a plan of action based on the results of both inspections.
