**RESOLUTION NO. 2018-67**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AWARD THE SPEED LIMIT SIGNS, FURNISH AND INSTALL CONTRACT TO A.U.M. CONSTRUCTION, INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE AMOUNT OF \$149,999.60, PURSUANT TO INVITATION FOR BIDS (IFB) 2017.11.MS AND SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD."

**WHEREAS**, on November 2, 2017, the Procurement Division of Finance formally advertised, issued, and distributed the IFB for Speed Limit Signs, Furnish and Install; and

**WHEREAS**, on November 13, 2017, a non-mandatory pre-bid conference was held with one (1) prospective bidder in attendance of the twenty-five (25) prospective bidders who downloaded the IFB package from Public Purchase, the City's web based e-Procurement service; and

**WHEREAS**, on December 5, 2017, six (6) bids were received in response to the Speed Limit Signs, Furnish and Install, IFB No. 2017.11.MS from: ABC Construction, Inc.; AGC Electric, Inc.; A.U.M. Construction, Inc.; Canyon Construction, Inc.; Metro Express, Inc.; and Pabon Engineering, Inc.; and

**WHEREAS**, the Public Works Department concurs with the Procurement Officer's recommendation to award the Speed Limit Signs, Furnish and Install contract to A.U.M. Construction, Inc. in the amount of \$149,999.60; and

**WHEREAS**, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on City contracts;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the Procurement Officer to award the Speed Limit Signs, Furnish and Install contract to A.U.M. Construction, Inc., the lowest responsive and responsible bidder, pursuant to Section 2-763 of the Procurement Code entitled "Contract Award" and Invitation For Bids (IFB) 2017.11.MS.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
