NEW BUSINESS:

Acknowledgment of new Board members

Two new Board members Ms. Vanessa Liebl and Ms. Philippa Milne were introduced and welcomed. Ms. Liebl advised Board of her website CHOICEMD.com and its services. Ms. Liebl stated she would gladly place information of Board events on her website and disseminate to all her contacts.

CILSF - Ms. Paola Villanueva - Services Provided

Ms. Villanueva addressed the Board regarding various programs which are offered by CILSF. Ms. Villanueva advised of upcoming training such as Money Management and that other training could be made available in groups of 7 or more. Ms. Villanueva also advised that if there is a consumer who is seeking services which they may not have available, CILSF will conduct research to locate such service and connect consumer with that entity.

Affordable Housing - Ms. Philippa Milne

Ms. Milne updated the Board on the progress of ongoing project in conjunction with ROOF (Residential Offering of Florida) regarding affordable housing for individuals with disabilities. Ms. Milne expressed her interest in seeing how the Board can assist with this project.

Casa Familia Accomplishment - Ms. Bonnie Blaire / Ms. Marie Whitehurst

Ms. Blaire advised Board of the accomplishment Casa Familia was able to achieve. Ms. Whitehurst informed Board Casa Familia was recently awarded by the Florida Housing Finance Corporation a total of nineteen million dollars which can be utilized towards the building of an affordable residential community for persons with disabilities within the Kendall area.

Inviting Guest Speakers - Ms. Mary Palacio-Pike

Ms. Palacio-Pike spoke to Board regarding Ms. Haley Moss who is a Florida Attorney living with Autism and that she believes it would be a great idea to invite Ms. Moss to participate as a guest at upcoming meetings/events.

OLD BUSINESS:

Adventure Day for All Event

Ms. Elejabarrieta advised date for event has been determined to be October 12, 2019 as previous discussed. However, Board members stated that this date is Columbus Day weekend which can mean a lot of the residents will be out of town and if it would be possible to change the date to October 26, 2019. Ms. Elejabarrieta advised City feels better it being in early October because then it would be too close to November and Holiday park assembly. Ms. Elejabarrieta stated she would review with staff and advise Board.

Ms. Elejabarrieta distributed current list of resources (Exhibit 1) which were part of last year's event and asked Board to review and add further information if available. Ms. Elejabarrieta will also be emailing list to Board members. Ms. Elejabarrieta also advised there may be a minimal fee extended to Vendors this year to cover expenses such as tent rentals, however it has not yet been determined.

Boccia is a unique sport that was specifically designed to create competitive equity between players with and without impairments that affect motor skills. Players on opposing teams score points by propelling colored balls closest to a target ball on a long, narrow, indoor playing court. In Boccia, all participants play seated, whether in a wheelchair or not. Balls can be propelled by throwing, kicking, or utilizing a ramp — making the game an extremely adaptable sport for players of all ability levels.

This program will provide participants with everything needed to start playing Boccia, including rules, drills, strategies, and all equipment (balls, chairs, and ramps). No experience needed.
