    - Staff suggested deferring the item since the project manager was not present to speak on it. Debbie stated that the neighborhood is happy with the installation of the sidewalks. However, the overall execution from the contractor is sloppy. Staff advised that the work is not yet completed, once everything is completed it will be up to standard.
