Panel members received the appraisal report for artwork under consideration by artist Agustin Cardenas, along with the proposal that was previously discussed. Staff asked direction from the Panel for locations to consider should the artwork be acquired. Members expressed concerns about the sculpture being placed outdoors based on its material and high-polish finish. Following additional conversation about artwork acquisitions in general and their placement, the following motion was made.
