**RESOLUTION NO. 2019-241**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE PURCHASE OF THREE (3) LIFEPAK15 CARDIAC MONITORS FROM STRYKER. AS A “SOLE SOURCE PROCUREMENT”, PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

**WHEREAS**, the current LifePak12 needs replacement due to being outdated and will no longer be serviceable; and

**WHEREAS**, the LifePak15 cardiac monitors are Advance Life Support equipment carried on all Advance Life Support Units; and

**WHEREAS**, the three (3) LifePak12 machines that require replacement are LifePak brand and must be replaced in-kind with the same brand; and

**WHEREAS**, the replacement cost for these monitors is \$69,365.28; and

**WHEREAS**, any other brand will result in additional cost for getting a new system and other changes to the Advance Life Support system; and

**WHEREAS**, Stryker, Inc. is the exclusive supplier of LifePak equipment; and

**WHEREAS**, Section 2-689 of the Procurement Code entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

**WHEREAS**, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

**NOW, THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation of the City Manager to waive the competitive process and authorizes the City Manager to purchase three (3) LifePak15 Cardiac Monitors, pursuant to Section 2-689 of the City’s Procurement Code.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


