**Agenda Item E-3**

An Ordinance of the City of Coral Gables, Florida, (City), amending the Code of Ordinances, Chapter 74 “Traffic Vehicles,” Section 74-208, “Study Criteria, Process and Expenses,” to require the applicant to pay an upfront fee to guarantee compensation to the City’s consultant for the methodology meeting; providing for repealer provision; severability clause; codification and providing for an effective date.

Mayor Valdes-Fauli: Next item, E-3.

City Attorney Ramos: E-3 is an ordinance of the City of Coral Gables, Florida, amending the Code of Ordinances, Chapter 74 “Traffic Vehicles” Section 74-208 “Study Criteria, Process and Expenses” to require the applicant to pay an upfront fee to guarantee compensation to the City’s consultant for the methodology meeting; providing for repealer provision, severability clause, codification and providing for an effective date.
