RESOLUTION NO. 2021-85

A RESOLUTION OF THE CITY COMMISSION TO RECONSIDER, A PREVIOUSLY APPROVED FIRST READING ORDINANCE, MORE SPECIFICALLY, [AGENDA ITEM F-1 ENTITLED: AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES AUTHORIZING ENTERING INTO A PURCHASE AND SALE AGREEMENT FOR THE SALE OF THE CITY-OWNED SURFACE PARKING LOT (#31) AT 350 GRECO AVENUE, CORAL GABLES, FL 33134 (FOLIO NO. 03-4120-017-2240) TO JRFQ HOLDINGS, LLC, A DELAWARE LIMITED LIABILITY COMPANY].

WHEREAS, on May 11, 2021, the City Commission by a 5-0 vote, unanimously passed and adopted the above-referenced First Reading Ordinance; and

WHEREAS, on May 25, 2021, the Mayor, after passing the gavel, moved to reconsider the City Commission's May 11th vote and that motion passed 4-0 with Vice Mayor Mena recusing himself; and

WHEREAS, after further discussion and presentation, the City Commission adopted the Ordinance on First Reading 4-0 with the Vice Mayor recusing himself;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission reconsiders the May 11th vote to adopt the Ordinance on First Reading.

SECTION 3. That the City Commission, after further presentation, public comments and discussion adopts the Ordinance on First Reading with a vote of 4-0, with Vice Mayor Mena recusing himself.

SECTION 4. That said Resolution shall become effective upon the date of its passage and adoption herein.


