New Business

Election of the Vice-Chair – Rolando Rodriguez moved to elect Christophe Difalco as Vice Chair. Mike requested a quick introduction before proceeding. Mike asked about how many vacancies the board currently has and if it would be possible to hold off the election for Vice Chair till the vacancies are filled. Staff advised that this item was requested by City Clerk, and they would have to make a motion to wait till the vacancies are filled. The Board decided to move forward with the motion on the floor to elect Christophe as Vice-Chair, seconded by Henry. All in Favor.

Landscapers parking on the street – Nestor explained to the Board the issue with landscapers blocking the right of way. The Board discussed possible solutions. The Board will discuss it further and invite Code Enforcement and Coral Gables Police Department to brainstorm a solution to the blockage.

Riviera pedestrian bridge – Nestor gave the Board a synopsis on this project. Nestor and a previous TAB member are requesting a pedestrian bridge cross to Ingraham Park. Staff advised that this is a county project. Matthew and Douglas Pinera also brought up concerns about lighting in the area. Staff advised that lighting will also be addressed as part of the project.

Swale restoration after sidewalk repair – Nestor asked staff if contractors are responsible for replacing damaged swale after a job is completed. Staff advised, yes.

Traffic calming for collector streets – Staff advised that Traffic calming is not an option for collector streets.

Letter advocating for the addition of inspectors - Henry, briefed the Board to an inconvenience with utility workers doing work outside of the allowable time frame. Mike advised that non-emergency would be the best contact. Staff advised that they can always call the main office.

Invitation to Raimundo Rodulfo – Henry would like to invite Mr. Rodulfo to the next TAB to discuss new technologies and ideas to aide in traffic calming. Staff advised that they will extend the invitation.
