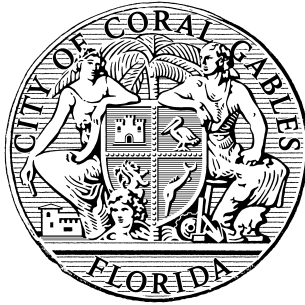

[Note for the Record (Agenda Items C-6 through C-21/Boards/and or Committee Minutes): Commissioner Cabrera prefaced his remarks by stating that he would like to talk about the presentation of board and committee minutes, a section in our Consent Agenda that requires no formal action by the City Commission, but said minutes are taken after every one of our board and committee meetings; further stating that said actions are helpful because it tells one what the boards are doing; what actions they have taken, as well as what are the hot subjects that the boards and committees are facing on a month to month, quarter to quarter, and year to year basis.

Commissioner Cabrera further explained to the viewing public that the Advisory Board on Disability Affairs had submitted minutes from its meetings of May 5th, 2010, July 7, 2010 and October 6th, 2010, respectively; that the Traffic Advisory Board had submitted minutes from September 21, 2010 and October 19, 2010; that the Cultural Development Board had submitted minutes from November 17, 2010 and November 29, 201; and that the Property Advisory Board had submitted minutes from December 15th, 2010.

Commissioner Cabrera continued to explain that it does not help him any to review minutes dating back to May of last year; pointing out to his colleagues that he uses said minutes to educate himself, to inform himself, and to bring up subject matter to the City Commission; further adding that said minutes are being executed late and he finds this practice to be unacceptable; further adding that this practice is an on-going issue, noting that he finds certain boards, such as the Advisory Board on Disability Affairs to be very important to him.

Mayor Slesnick further added that the City should not maintain a board if it is not important; further instructing the City Manager to look into why there is a delay; or if there is a reason as to why the minutes of boards/committees are late.

Commissioner Cabrera added that for the most part, the practice of receiving our city's Boards/Committee minutes have at worst 90 days in arrears, but to allow said practice to go to 9 months is not what he would like to see; further requesting of the City Manager to have this matter corrected; further citing that he would like to see the City staff go back to the time frame we were abiding by].

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE BILTMORE GOLF COURSE REMEDIATION PROJECT TO CHEROKEE ENTERPRISES, INC. IN THE AMOUNT OF \$86,633.03 PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD" AND REQUEST FOR PROPOSALS (RFP) 2010.11.01.

[Note for the Record: Commissioner Cabrera stated that the purpose of pulling Consent Agenda Item C-5, was not to discuss the award of the Biltmore Golf Course Remediation Project to Cherokee Enterprises, Inc., but to just to have our City's Administrative staff briefly explain to him what this matter is all about.

Public Works Director Glenn Kephart responded by stating that this particular project is to remove some contaminated soil containing arsenic which has accumulated over the years, from the Biltmore Golf Course; further explaining that over the years there were some materials used for the maintenance (herbicides, pesticides, fertilizers, etc.) which have built up over the years that would contaminate the ground water; further explaining that the City is under obligation to remove this contaminated soil, and take same to an approved site for these types of materials.

Commissioner Cabrera further inquired of Public Works Department Director Kephart as to whether said contaminants will be transported to an approved site on City land?- further inquiring as to whether such transporting of contaminants is part of the Department of Public Services responsibility?- whereupon Mr. Kephart responded

that the Biltmore Golf Course is maintained by the Biltmore, but it is public land; further adding that said project will be managed by the Department of Public Works.

Commissioner Cabrera further explained to the viewing public that the City needs to clarify what the issue is; further informing his colleagues that he had received an inquiry stating that there was ambiguity and/or concern regarding this matter; therefore, he felt that there should be an explanation regarding what this issue was all about].

[Note for the Record: Interim City Attorney Lourdes Alfonsin stated that the proposed resolution was to waive any potential Conflict of Interest that the firm of Akerman Senterfitt may have during its representation of the City of Coral Gables in the matter of FPL's application for the approval of the Turkey Point Site expansion and Transmission Lines 6 and 7 and all other associated facilities.

Interim City Attorney Alfonsin stated that if Akerman Senterfitt is still to represent Coral Gables, then both Florida Power & Light (hereinafter referred to as FP&L) and Akerman Senterfitt have to sign waivers of conflict; further stating that through former City Attorney Elizabeth Hernandez, she worked on FP&L's application for approval of the Turkey Point Site expansion and Transmission Lines 6 & 7 for several months; further explaining that the City of Coral Gables is desirous of continuing representation by Akerman Senterfitt in the FP&L Turkey Point Expansion, Transmission Lines 6 and 7, hardening projects and all other associated facilities; further citing that there has been a communication between the city and FP&L regarding this; further pointing out that an extension was given to all of the affected cities at the request of Akerman Senterfitt through former City Attorney Hernandez.

Questions, Answers, Inquiries and Concerns by the City Commission: Commissioner Anderson inquired as to what are the deadlines coming up in connection with FPL's application for approval of the Turkey Point site expansion and transmission lines 6 and 7?- whereby Interim City Attorney Alfonsin responded that May 1st, 2011 will be the first deadline, and that June 2011 will be the second deadline regarding said matter.

Commissioner Withers stated that Akerman Senterfitt has represented the City before in the negotiations with Florida Power and Light (hereinafter referred to as FPL) as to where to put the transmission lines; further stating that the City was not in favor of initially jumping into this feet first; further adding that he does not know how much involved the City has progressed with this, as it has now.

Mayor Slesnick stated that one of the reasons that the City did not jump in feet first, is because the City is desirous of knowing as much of the facts, versus just saying yes, no or giving any response; further stating that as facts were developing, that a debate ensued between the U.S.-1 Corridor versus the Alternate Corridor (i.e. Expressway System); further pointing out that former City Attorney Elizabeth Hernandez went to North Dade to observe the poles and sent photographs of same; further adding that one of the other Mayor's from the south corridor, was using said matter to trigger a battle between nuclear power plants and the direction of the poles; further noting that the law firm of Akerman Senterfitt represented the City of Coral Gables during these negotiations.

Mayor Slesnick acknowledged that Ms. Hernandez became one of the lead attorneys in all aspects of this issue, in expediting and facilitating a debate on alternate routes and alternate corridors; further noting that she was viewed upon by the Miami-Dade League of Cities and other cities as the lead person in this matter.

It was further explained that there was concern when she left the City of Coral Gables and joined Akerman Senterfitt Law firm that Florida Power and Light Company could possibly block her initiative; however, FP&L granted a release of any Conflict of Interest, in order that former City Attorney Hernandez would be part of the Akerman Senterfitt team, if said firm was desirous of her continuing her involvement with this matter; further stating that the law firm of Akerman Senterfitt has more knowledge about this matter (i.e. contractual negotiations) than anyone; further stating that in the end the City Commission will have a very specific final decision to make regarding what is the Commission's decision (i.e. this is the position of FP&L; this is the route they are pushing; do we agree or not?) will be as a collegial body.

Mayor Slesnick further added that by having Akerman Senterfitt use former City Attorney Hernandez, the City is getting benefit of the expertise and background knowledge that she acquired while she was here.

Commissioner Withers inquired as to whether the City was being billed by Akerman Senterfitt now?-whereby the City Attorney responded in the negative. Commissioner Withers acknowledged that the City has not yet retained Akerman Senterfitt; further adding that there will be a decision at some point regarding how involved the City will be].

K. DISCUSSION ITEMS

Mayor Slesnick: Ms. Anderson.

Commissioner Anderson: You know, I'm good.

Mayor Slesnick: Mr. Cabrera.

Commissioner Cabrera: I wish I was as good as Ms. Anderson. I have some quick questions or comments. Let me begin by letting you all know, maybe you've received this, but I received in my office a petition that was submitted to all of us by the, what it seems to be the neighbors that live along the 1100 block of Lisbon Street and in that vicinity, because apparently over a period of years there had been some dogs that had roamed the neighborhood and have killed cats and they have attacked other leashed dogs and they have frightened residents and in fact in one incident or several incidents they have bitten a resident; and there are reports on file with the Coral Gables Police Department regarding this, and so these good folks that live on Venetia and on Lisbon, El Rado and that vicinity have asked us to please take some action on this issue, and while I'm not a big proponent of petitions, I really do believe this is a life safety issue, and I'd like to see the City take a proactive approach to this before someone really gets injured, and there may have been already an injury, I don't know. I've spoken to one gentleman who's been very interested in trying to curb the problem. So did any of you get this?

Commissioner Anderson: No.

Commissioner Cabrera: No?

Mayor Slesnick: Yes. I've sort of been involved in this for a couple years in the sense that this one resident of the street has basically driven the other residents crazy. He's a resident...

Commissioner Anderson: He's on Lisbon, isn't it?

Mayor Slesnick:...Yes, he's a resident that does not necessarily keep his house in accordance with the standards of the other residents of the neighborhood, and he has dogs as you mentioned, and I think Ralph, that you'll find that our Code Enforcement

people have responded to this address and to these complaints numerous, numerous times and maybe the Police too, I'm not sure of that, as you said they did. I don't know - absolutely, I mean it's the kind of thing that drives you crazy, because he's driving them crazy.

Commissioner Cabrera: There are forty-two (42) residents that signed this...

Mayor Slesnick: I understand that.

Commissioner Cabrera:...Not only did they sign it, they gave us their phone number, they gave us their e-mail, they obviously have a serious concern about this, and really, I've been by there and I've never seen the dogs, but I'm been told that they are out there and that they cause a great deal of anxiety amongst the community, and I just think now it's becoming a life safety issue, and so I'd like to see the City take a proactive...you know, the key word for me here is proactive.

Mayor Slesnick: Since that petition came in crime watch went out there and had a meeting, and again gave the residents an opportunity to expound upon it and also shared with them things that they might do, but obviously that didn't necessarily cure the problem.

Commissioner Anderson: Animal control?

Commissioner Cabrera: Animal control services?

Commissioner Anderson: What role has that played?-because I mean, we did that in the past.

Commissioner Cabrera: I don't know. Our Police Department is....

Commissioner Anderson: I don't know, just a question.

Commissioner Cabrera: A good question too. You know, the concern here is, we've been given a complaint by 42 residents, and it seems to be an ongoing problem and from the little discussions I've had with these residents it seems to me like when the problem occurs whether it's a cat that's killed, a resident that's bit, another dog that's leashed attacked, this one or several dogs go away, and the problem goes away, and then couple months later the dogs come back, you know they went on hiatus, or they

went to dog obedient school, or the dog “whisperer” and they failed they miserably failed. So then they come back and this thing starts over again; one day something bad is really going to happen here and then we are going to say, remember the time we got that petition we got from those 42 people. OK, I see the eyes are going up. Hey, could staff look at this then? To those that are watching that live on Lisbon and Venetia and those streets, I’m concerned about the problem and I care about the issue and I will see to it that staff does everything appropriate to react to it.

Commissioner Anderson: Including animal issues of animal control.

Mayor Slesnick: Ralph, Ralph.

Commissioner Cabrera: Yes, I’m moving forward, I’m moving forward.

Mayor Slesnick: Wait, wait, wait.

Commissioner Cabrera: No, I’m moving forward, it’s my time.

Mayor Slesnick: Can I just say something? Don’t you want somebody to jump in and support you?

Commissioner Cabrera: Not really. I pretty much let staff know how I feel about this.

Mayor Slesnick: OK.

Commissioner Cabrera: I want to thank the Parks and Recreation Department and specifically Christina Martinez, Fabio and forgive me for not remembering Fabio’s last name, is it Rodrigues?- Fernandez?- I apologize, but Fabio works in the Parks and Recreation Department, he’s being honored this month as our Employee of the Month, and of course our Director, Fred Couceyro for an outstanding Daddy/Daughter Dance. It was held last Friday at the Fairchild Tropical Gardens, it was extremely well attended, and I have to say this was my fifth year participating in the Daddy/Daughter Dance, and this was by far - every year it seems to get better and better. So to the folks in the Parks and Recreation Department who care so much about these kinds of special events my hats off to you. I don’t think there was one person in that event that didn’t have some wonderful things to say about the way that the City staff organized it. The food was very good and the music was charming, and it was just a very nice night and so I want to thank the Parks and Rec. Department for a job well done. Look

forward to next year's Daddy/Daughter Dance. And last but certainly not least, I'd like to take this opportunity to chat with the Commission regarding the briefing that we received several Fridays ago or several Thursdays ago - Friday, thank you, I stand corrected - two Fridays ago for those of you who really are not familiar with what I'm speaking of, the Coral Gables City Commission received a briefing from the firm of PriceWaterhouse; two consultants from PriceWaterhouse were there and I spent about an hour and twenty minutes. Along with them were representatives from Akerman Senterfit as well as our other consultant Mr. Reeder Glass, and our Interim City Attorney, and our City Manager, and while I'm not necessarily interested in talking about the details that had been publicized by many throughout this community, and seems to be a favorite topic of the blogs these days, I would like to find out from this Commission where do we go from here?- what direction do we want to give the Manager's office?- do we want to just wait another nine months?- do we want to continue to do more evaluation?- because after all the folks from PriceWaterhouse spent nine months reviewing the Biltmore Hotel and prior to that we had an internal audit completed by staff, and therefore I'm very interested in knowing what the next steps are.

Vice Mayor Kerdyk: I have a comment on that; I have a comment, matter of fact I have two comments. One is that I believe we had a briefing, I asked some additional questions that PriceWaterhouse is supposed to get back to me with those answers. I want to see a written report at some time too, I don't think we need to wait for a written report to start our discussions with the Biltmore Hotel, but what I would encourage the City to do or the City staff meaning the City Manager is to reach out to Mr. Prescott and set up a meeting so that he can discuss this report with Mr. Prescott. So, I don't know if you have that planned or not, but I think we do need to get this discussion going and move this process along on an expeditious basis.

City Manager Salerno: Mayor? Thank you Mayor. Along those lines, I've been advised by PriceWaterhouse that they should be prepared within two weeks to issue its report. That triggers a process as called for by the escrow agreement, which we will follow. In addition, I've recently had a conversation yesterday with Mr. Prescott, and he is checking his calendar now for dates that he is available, and we are scheduling a meeting to pursue our discussions. That has already been - the process has already started and we'll be setting a date here; Mr. Prescott advised me that he should get back to me on Wednesday or Thursday with dates that his folks are available and so we should be setting a date for those discussions to proceed.

Mayor Slesnick: Ralph.

Commissioner Cabrera: I'd like to have some time definitive - I'd like to have a time definitive element in all this and so I want to know, because I remember, maybe you all don't, but I remember when we would ask the question about how the audit is coming along, and incidentally is not an audit, it was an evaluation of their operations, not an audit, and I was corrected by the folks at PriceWaterhouse. The point is that we would ask, I remember Mr. Withers was probably the point person on this, and he would ask and we would hear back that it was almost completed, it was almost done and that there were some things that needed to be finalized, whatever the responses were. I don't want to go another two, three, four months in this exercise, you know, we've already gone through the evaluation for nine months and before that as I said, as I'm repeating myself, we had internal workers do some things with the folks that manage the Biltmore and so I need to get a sense that we are moving this thing forward in an expeditious manner, and I don't always come away feeling that way.

Commissioner Anderson: Well you know, I appreciate that; the escrow agreement triggers some things that are documents, so I think there would be to the benefit of the Biltmore to begin to come to the table as well as with the Manager, because I think the escrow agreement will begin to have issues with the documents being released.

Commissioner Cabrera: This is just an observation, this is not, I can't say this for sure, but I'm willing to bet you that the folks at the Biltmore would be willing to meet as early as this afternoon with the Manager's office. I really believe that they are anxious to get this thing going too, Ms. Anderson. I don't think they are the one's that's slowing this process down, they want to move forward, and begin discussions which is really what I'd like to see happen.

Commissioner Anderson: I think there has been delays on both sides to be honest with you, that's my belief....

Commissioner Cabrera: Yes, they have, yes they have, you know you're right.

Commissioner Anderson:...because the Biltmore was discussing documents they wanted to get back and forth; but now that we are here that's old stuff, let's just move forward as quickly as we can.

Commissioner Cabrera: You're right about the data stuff, the information stuff, but I

think they have always been willing to talk; they've always been willing to talk, that's what I come away with, they've always been willing to open dialogue.

Commissioner Anderson: That's fine. I'm all for doing that and trying to get some information back and if the Manager can meet as quickly as possible. I think we also have to include our counsel, which is Reeder Glass who comes from out of town.

City Manager Salerno: There will be the appropriate representatives; my discussions with Mr. Prescott are that he'll have his team there and we will certainly have our team involved in the discussions as we begin them.

Commissioner Withers: Do you plan to share any or part of the PWC study with them at that time if they ask?

City Manager Salerno: No, it's not in my intent to share that information; it's my intent to have an open discussion with them on the matters that they think are important to them, and those that staff believes are important to the City, and we'll see where that takes us. There is a separate process that goes forward; I heard a Commissioner ask for that they'd like to see a written report; we've been advised by PriceWaterhouse when they estimate that they'll be prepared to within a certain timeframe, so we'll proceed along those lines, but we don't control that timeframe. The City Attorney can certainly respond subsequently to explain the timeframes, but there are obligations on both parties as to how to proceed and we don't control the entire process how that process goes forward.

Commissioner Withers: The purpose of my comment is I think there is a desire for an expeditious, at least, movement to get this thing going, and if you did say that PriceWaterhouse was going to be issuing a report...

City Manager Salerno: Prepared to issue.

Commissioner Withers: Oh, they are not going to actually prepare; they are not going to release one then?

City Manager Salerno: Prepare to issue the report is the effective language in the escrow agreement, and the Biltmore has certain rights and they are not going to violate what the agreement says.

Commissioner Withers: Right. Let me make sure I understand that process. Because I read the escrow agreement and I'm not - it seems that it's not necessarily the report itself that would cause issues if it was produced, but the backup materials that support the report, some of the confidential materials according to the Biltmore that they submitted to the PriceWaterhouse create the report, and so the concern would be that any of those collateral materials are the ones that would be redacted out of the report. Is that correct or incorrect?

City Manager Salerno: I want to defer to the City Attorney at some point, but I believe it's broader than that, it could include the conclusions, etc. , that they might feel should be included.

Interim City Attorney Alfonsin: There are certain documents that are attachments that made the part of the escrow agreement that have to be removed, but the report that refers to those attachments may also have to be redacted because of the removal of the documents, the referrals to those documents.

Commissioner Withers: Listen, I think that we all agree that Richard Nixon's - the tapes, the erased parts of the tapes that really caused all the furor. I guess that shows how old I am. So there is a report and the Biltmore will be able to look at that report and challenge whether what should be in that report or pulled from the report?

Interim City Attorney Alfonsin: No.

Commissioner Withers: OK. How does that work?

Interim City Attorney Alfonsin: The escrow agreement - well yes, up to a certain extent. The escrow agreement dictates what is allowed to become public and the City along with the Biltmore would make decisions as to what as part of that report can be public, and cannot pursuant to the terms of the escrow agreement.

Commissioner Withers: OK.

Interim City Attorney Alfonsin: And that would be both as to attachments and referrals within the report itself.

Commissioner Withers: OK. But I guess at some point if PWC comes forward with a report, the Biltmore is going to know obviously what's in that report because it's going

to be a published report.

City Manager Salerno: Well, I would hope even at this point the Biltmore knows their own operation, all the information that PriceWaterhouse considered came from the Biltmore. I think you have to look at it and say, does the Biltmore understand their own finances, their own operations and certainly on par with and certainly probably better in some respects than PriceWaterhouse does.

Commissioner Withers: But if this Commission is going to make a decision on information - I think all of us agree that we are not going into this as an adversarial approach....

Commissioner Cabrera: It was never my thought process to do that.

Commissioner Withers: I know. We are looking for a solution, and so I just think that we and the Biltmore should have a common starting point so we are all working off the same information. I'd hate for anyone here to make inferences - I don't know what I'm trying to say. I'm trying to say that at some point if we are going to have an open discussion with the Biltmore we all kind of need to be starting from the same point. They need to know what we know and we need to know what they know. I know down the road that causes issues as far as potential lawsuits and things like that when you start going on the record with stuff like this.

Mayor Slesnick: Chip, as a negotiator I mean, there are times when you negotiate with people that you do not know and you are out to get the best of the deal, and then there are times when you are negotiating with people that you know and deal with on a regular basis, and I have to concur and I think Pat, I've been very open about this and I said this at our meeting; I think that as much as we can share about the analysis of PriceWaterhouse with the Biltmore it's just not - I went through the briefing; I didn't consider anything I heard and they may have other stuff that you consider proprietary and that you want to use and coming down to a final decision and that's fine, but the stuff I heard I thought that it would be fine to share with the Biltmore and try to keep everybody on the same sheet of music and start off on the same sheet of music. I think they should hear some of PriceWaterhouse's analysis; the information, you are right, the information was given to them by the Biltmore, but PriceWaterhouse made some comments about what they thought the future or the uptick was for the Biltmore or the possible downtick, and it just seems to me that it's worth sharing. There is a whole other set of negotiations even in labor relations that we started where we go in and

share all the information and do all that and start at a very open and sometimes it works and sometimes it doesn't.

City Manager Salerno: What I try to convey is we are going to start having hopefully meaningful discussions that encompasses all of that; we can't have meaningful discussions without exchanges of positions and information, etc., but there are two parties and we'll proceed along those lines.

Commissioner Withers: Like Ralph was saying, when do we actually sit down?- what is the next step?- you meet with them and then you meet with us individually?- or you meet with us collectively? How do you see the events unfolding over the next two months, three months, six months on this?

City Manager Salerno: I'll be able to give you a better indication of that after I have my first meeting. I mean, that would be like pre-judging a negotiation of any sort and saying what's the outcome going to be? You haven't even sat down yet, so. I've negotiated many deals in many different forms over many decades and anybody that goes in trying to predict a timeframe to a conclusion that's being discussed I think is not - is guessing.

Commissioner Cabrera: Let me be specific, OK, because I don't want this to be clouded. I don't know how long it's going to take, I don't know. It may take a month, it may take three months, it may take nine months, but I want something to begin, I want something concrete, I want to be able to see a start, and I want to know about it not by reading a blog, or talking to a candidate, but by knowing as a sitting Commissioner that this is happening. That's what I'm looking for and I don't think that's too much to ask for, and if any of you think it is speak up. That's all I want. That's all I want.

Commissioner Anderson: I agree.

City Manager Salerno: That's what I said.

Commissioner Anderson: And what Chip said was that we all start on the same base line that's really important because in the summer time whenever that was, I forget if it was last summer or the summer before last, everything blurs now, there was a lot of misinformation. I was told one thing and when we came forward it had changed for whatever reason. So I want a baseline of information that we all have both sides, so

we don't go at cross purposes to one another. I just want to reiterate that for everybody's benefit.

Mayor Slesnick: OK. And Pat could we ask you to give us a report next time as to what has happened in the intervening two weeks, because you said things will happen you hope, if nothing has happened, but if you bring us up to date. I'm not talking about the substance, I'm talking about what just happened, in other words if PriceWaterhouse is ready to issue the report and the escrow agreement has begun its operation, whether or not you and Mr. Prescott have met, just some kind of update for next meeting.

City Manager Salerno: Yes. Sure Mayor.

Mayor Slesnick: OK.

Commissioner Cabrera: That concludes my formal discussion period.

Mayor Slesnick: Thank you. Mr. Kerdyk.

Vice Mayor Kerdyk: Don't have anything Mayor.

Mayor Slesnick: Mr. Withers.

Commissioner Withers: No sir.

Mayor Slesnick: Just a few things. One is, Pat, you and I have discussed and I have expressed to you my concerns as I had, in fact it even came up during our discussion of the Miracle Mile redo about the staffing of our Police Department and our law enforcement officers. If you are prepared now or if you need time, but I would like an update on where we are and the number of officers, and how we are staffing our department and what we are doing to maintain full staffing, if that is in fact our goal.

City Manager Salerno: Certainly Mayor. There are 183 positions listed in the budget, we have currently - 183 sworn positions, there are 13 sworn vacancies, the Police Department has been authorized to fill three of those positions right now and they are in the process, I understand that they have three people that are in the process of going through final stages of background work, hopefully they will be successful in that regard, but that's not a process that you can pre-judge. With those three positions

filled we would have a vacancy rate of five percent in the department which is a normal attrition rate for a law enforcement agency of our size. Concurrently as you all know, we recently had a re-rating by Moody's. One of the things that they looked to in a positive vain was that we were monitoring and making adjustments to our expenditure rates. That was one of the things that they took note of and kept our ratings from being adjusted further. We've just been notified, the Finance Director just notified me that we are now, our bond ratings from S&P (Standard and Poor's) are at this moment currently under review, and we certainly expect to make a point in explaining to them that in these trying economic times that management of this organization is monitoring our expenditures and holding the line in a prudent fashion. We'll relook at the issue of vacancies once the Police Department has acted on the three that they've been authorized. I hope that they will be able to fill them soon, but that is a matter internal to the department as to how to proceed.

Commissioner Cabrera: So the Manager indicated that there are how many open positions for Police officers?

City Manager Salerno: All sworn - sworn, that is the entire rank and that's the way typically you look at it. There are 13.

Commissioner Cabrera: I look at it based upon a report that I requested that I think the rest of the Commission received on vacancies as of January 26, 2011. Based upon the list that was provided to me there are 9 open positions for sworn Police officers, not Lieutenants, not Assistant Chiefs, not Police Chiefs, 9 Police officers, does that sound about right?- I mean, I'm looking at the report. I can make copies for everyone here; it's dated 1/26/11.

City Manager Salerno: Nine - yes.

Commissioner Cabrera: Nine - and you just shared with us that you are authorizing the hiring of three.

City Manager Salerno: Not now, they have been authorized.

Commissioner Cabrera: They have been authorized; three have been authorized.

City Manager Salerno: Yes, and they are in the process right now of filling it.

Commissioner Cabrera: Of hiring them - OK, that's fair. I'm just curious, we have four Firefighter positions that are open, how many have we authorized to hire for those Firefighters?

City Manager Salerno: Three.

Commissioner Cabrera: Three. OK. So we are hiring - we've got nine sworn Police officers, I'm assuming probably patrol, and we are authorizing a third of those to be replaced, and we've got four Firefighters and we are authorizing 75 percent of them to be replaced or higher than that. OK. It doesn't make sense to me, but...I tell you what's going to happen, I'll say it today, because I want it to be out there as a public record. We are going to have a tragedy in our City, I don't know what that tragedy is going to be, and I hope to God I'm wrong, I really want to be dead wrong, but when that tragedy occurs whether it be a home invasion or something awful that occurs where someone gets injured and we are going to have an issue with a response time based on that, God help us all, God help us all, and it will start with the politicians and it will trickle all the way down. So that's what I'm fearful of that we have nine Police officers, are potentially patrol officers that we are down and we are only hiring a third back. This City has always had a tremendous reputation of making sure that we have Police presence throughout our neighborhoods, throughout our downtown areas. You know, we had a Special Commission meeting here not long ago and we were talking about the downtown area and how important it is, and how we need to make sure that we renovate that streetscape, and we make sure that it becomes a thriving downtown that it once was, but you know that today go find me a Police officer on a bicycle in the downtown area, I urge you to, find me a cop on a bike, you don't find them because we are down on Police officers. So those officers are now in cars doing other things. So yes, we talk the talk about doing the streetscape and making sure that the downtown looks the very best it can, and we talk about the importance of hiring, we talk about Moody's, but God forbid this City should go through a tragedy, someone's family, someone's mother, someone's father, someone's son, someone's daughter gets injured and we have a problem with our response time then you know what?- the five of us are going to be held liable for it, and it's sad. So, I'm telling you that I for one do not find it acceptable that we are hiring three officers when we are down nine.

Vice Mayor Kerdyk: Can I ask a question? Are you finished Commissioner?

Commissioner Cabrera: Yes sir, I am.

Vice Mayor Kerdyk: What bothers me, and maybe it won't bother me once you answer this question, but I always look at what's the potential loss of Police officers over the next year or two. Do you take that into consideration when you are analyzing?

City Manager Salerno: Oh, absolutely Commissioner.

Vice Mayor Kerdyk: Because the last thing we do want is for it to exacerbate any more than it is now. The fact is that like Commissioner Cabrera and like all of us, we are concerned with patrolling police officers, and we want to make sure that there is a threshold that we don't get lowered, and you've named that threshold at five percent, but the fact is police officers move on to other locations, retire and there are some vacancies, that always bothers us up here and I just want to make sure that is something that you are looking into.

City Manager Salerno: Absolutely. Let me just emphasize again. Once the department acts on those three we will relook at that situation again, it is in their hands right now. If they fill those three tomorrow, and I certainly hope they will, we will relook at it at that time, I'll sit down with the Chief. I had a discussion with the Chief within the last week and I encouraged him to put whatever the resources are to move it along on his end of the process. Let me share some good news with you from a law enforcement perspective. This information is as fresh as you can get, in fact we are waiting right now on FDLE to accept our report which is for the crime stats for the past year, meaning through comparing calendar year 2010, which just ended a month or so ago, to calendar year 2009. I'm pleased to report total that total non violent crime in the City from that one year period has dropped seven (7) percent; total violent crime has dropped seven (7) percent; burglaries over that period have dropped twenty (20) percent; burglaries attempted have dropped fifteen (15) percent; shoplifting has dropped twenty-three (23) percent; left from a motor vehicle dropped twelve (12) percent; and motor vehicle theft dropped thirty-one (31) percent. So I think....

Vice Mayor Kerdyk: That's unbelievable statistics. Can you share those with the Commission?

City Manager Salerno: I will. I need to caution they have been reported to the FDLE (Florida Department of Law Enforcement), they haven't been accepted yet, that's why the Police Department hasn't issued them yet. I have them, there is no reason to not accept, not expect FDLE accept them. So I think we are able to report very positive outcomes from the prior year, the men and women certainly deserve credit in that

regard, and like I said, you need to be - there is not one thing we emphasize, we look at the whole patient so to speak. This patient, meaning the City still remains acutely vulnerable to financial setbacks and we need to be ever vigilant in that regard, and particularly now since we have the other major bond rating agency S&P reviewing that we are being prudent in our financial decisions as we manage the organization. So again, I will get you copies of this, just keep in mind that they've not yet been accepted, but I would be surprised, shocked you might say, if they didn't accept them, and it's a very positive report on the public safety situation in the City. So I hope you all are pleased.

Vice Mayor Kerdyk: That's fantastic considering the economic downturn that we are experiencing in the City, State and nationally, and John take it back to the Police Department how much we appreciate them working so diligently to make sure those numbers have decreased so much over the year before. Thank you.

Unknown Speaker: [Inaudible - off mike]

Vice Mayor Kerdyk: Thank you.

Mayor Slesnick: And I had asked this question originally so let me close my point with saying that number one, Ralph you may remember that in the close of the Special Meeting about the streetscape on Miracle Mile, I did suggest that we need to worry if we are going to bring more people to Miracle Mile and make it pretty that we need to worry about people's safety there, and we need to have a presence, and we need to...

Commissioner Cabrera: I do remember you saying that.

Mayor Slesnick: So that did concern me and like I say, I've talked to the Manager about this, and it's not something I'm surprising him with, because I continue to be concerned. My background has been 40 years around Police Departments and Police officers and I respect greatly what they do, and I am concerned and I will continue to express my concern that we staff as well as possible and that means that everyone will feel safe in their homes and their businesses, and I'd like to see Police officers downtown too circulating and riding their bikes, I guess we don't use the segways anymore, but anyways - you know Police officers make a community feel good about themselves. I feel the same way about the Fire Department, I mean our uniform services are both the kinds of services that people feel safe in their homes and safe on the streets, and they love to call 911 when they have to and know that there is going to

be a full and quick response, that's something we can be proud of that we've always given them and want to continue that. One thing that I - just two more - three more things quickly, but one thing I wanted to say to you is I'd like to bring a resolution to you to consider just to express to our State Legislative Delegation a concern for one of the Governor's proposals is to close a number of the State parks, including the Barnacle in Coconut Grove and its funny, because I just read this wonderful article in the Herald the other day about the opportunities for going to the parks here in South Florida, and for those of you who like myself over the period of your life have enjoyed your State parks and have been proud of Florida for some of that. So I didn't want to bring a resolution unless I asked if there was any objection via statement of sentiment that we hope that they will use caution and concern in doing such a thing like that. The other thing is if you all read the community newspaper had a survey, they had almost 500 people respond, and I just thought it was a wonderful thing. We hear people criticizing the City, the people that criticize are loud and speak up often, but in a 1 to 10, 1 being the lowest rating and 10 being the highest rating, of the 500 - well I want to be exactly accurate, 478 survey responses, everything in the City was rated 7 or above. All of our departments and the overall quality of life in the City Beautiful was rated a 9 by those responding; I'm not suggesting that it was probably a scientifically accurate survey, but it was done and I thought it would be nice to proclaim that. I also thought it was a nice letter to the Herald that was written by Bill Sprat concerning our Building and Zoning Department, complimenting them for the work that they are doing, and the changes that have been made there. And finally, we continue to hear more and more discussion of public sector pensions. I just came back from a meeting of labor employment lawyers from around the country; lawyers that are neutral, lawyers that are management lawyers, lawyers that are union lawyers, talking about pensions. It's an issue that faces every community almost in the United States, every State in the United States, and it faces us; and we as a Commission, and one of the things I keep trying to tell people I've been proactive for a long period of time and there was an article, a headline, excuse me, the lead editorial in the Herald about taxpayers due fairness in pensions, state workers must pay their share, it talks about the Governor's recommendations for the State pension system, and I was able to say to one person recently and proudly, not that our work is finished, not that the employees of this City and the management of this City and the elected officials of this City do not face more challenges in this area, because there are deep challenges, but the fact is that the unions of this City and the public officials of the City have already done what it looks like what the Governor may do with the State system in the coming days of the legislative session. And with that, I just think that this Commission can take pride in the fact that with the union's cooperation on paying contributions to the pension plan we've taken

steps that the Herald is pushing that the Governor take in the future. We think that everybody here has been very responsible in that area; and again, as I say, it doesn't mean that all the challenges are over, doesn't mean that all the fixes have been fixed, it means that we have, I believe everyone from the rank and file on up has acted responsibly in this area. With that, we will be back in two weeks and at that time we are going to have City Attorney interviews as a set time at 1:00 o'clock that day, same day.
