**RESOLUTION NO. 2021-207**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CULTURAL DEVELOPMENT BOARD TO APPOINT NELSON DE LEÓN, ADLER GUERRIER, EUGENIA INCER, JACEK KOLASIŃSKI, EMILY MACDONALD-KORTH, MARIJEAN MIYAR, AND JUAN ROSELIONE-VALADEZ TO THE ARTS ADVISORY PANEL TO SERVE FOR A TWO (2) YEAR TERM, WHICH BEGAN ON JUNE 1, 2021 AND CONTINUES THROUGH MAY 31, 2023.

**WHEREAS**, the Arts Advisory Panel is comprised of nine (9) members, with the Cultural Development Board recommending seven (7) member appointments to the City Commission; and

**WHEREAS**, on July 28, 2021 the Cultural Development Board voted to recommend reappointment of the eligible members of the Arts Advisory Panel; and

**WHEREAS**, on July 28, 2021 the Cultural Development Board voted to recommend appointment of one new member to the Arts Advisory Panel; and

**WHEREAS**, the following recommended appointees have agreed to serve: Nelson de León, Adler Guerrier, Eugenia Incer, Jacek Kolasiński, Emily MacDonald-Korth, Marijean Miyar, and Juan Roselione-Valadez;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.


