RESOLUTION NO. 2008-99

A RESOLUTION OF THE CITY OF CORAL GABLES COMMISSION WITH ATTACHMENTS, OFFICIALLY ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF RESULTS OF THE CORAL GABLES TRIAL BOARD ELECTION, HELD ON JUNE 6, 2008, WHICH ELECTED JOE GREENBERG (1 YEAR TERM) AND FELIX PARDO (2 YEAR TERM), RESPECTIVELY.

WHEREAS, On April 8, 2008, the City Clerk forwarded to all excluded employees memorandum and nominating petition form, thus calling said employees of Coral Gables to nominate two citizens of Coral Gables to be elected in order to serve on one and two year term, as members on the Trial Board; and

WHEREAS, On June 6, 2008 the excluded employees of the City of Coral Gables, who voted in the Coral Gables Trial Board Election, voted by a 55.17% (32 votes) to 44.83 percent (26 votes) margin for candidate Felix Pardo in Seat No. 1 as a representative on said Board for a two year term; and voted by a 53.70% (29 votes) to 46.30% (25 votes) margin for candidate Joe Greenberg, as representative in Seat No. 2 on said Board for a one year term; and

WHEREAS, at approximately 5:01 p.m., on June 6, 2008, Election Day, the City of Coral Gables Canvassing Board for said election met and proceeded to publicly canvass the votes given for said Trial Board Election, and as a consequence thereof, certified the official results from the Coral Gables Trial Board Election; said returns which are on file in the Office of the City Clerk; and

WHEREAS, the City Clerk has prepared his Clerk's Certification and Declaration of Results, along with pertinent support documentation of the Coral Gables Trial Board Election, for consideration, review and approval by the Coral Gables Commission; and

WHEREAS, in accordance with Coral Gables Code Section 2-120, the City Clerk did receive written notification and willingness to serve from recently elected Trial Board members Joe Greenberg and Felix Pardo;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF CORAL GABLES, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission of Coral Gables does hereby accept the City Clerk's Certification and Declaration of the Results of the Trial Board Election, attached hereto and made a part hereof, held on June 6, 2008, in which Candidates Felix Pardo (Seat No. 1) and Joe Greenberg (Seat No. 2) were elected to serve for a two year and one year term, respectively.

SECTION 3. That on June 9, 2008, the City Clerk did receive a notification of acceptance and willingness to serve from Joe Greenberg; and that on June 16, 2008, the City Clerk also received a notification of acceptance from Felix Pardo.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
