RESOLUTION NO. 2020-107

A RESOLUTION OF THE CITY COMMISSION AMENDING ORDINANCE NO. 2015-17, AS AMENDED, TO REVISE VARIOUS LOCAL BUSINESS TAX CLASSIFICATIONS, AS PROVIDED FOR UNDER SECTION 205.0535 OF THE FLORIDA STATUTES; PROVIDING FOR A REPEALER PROVISION, SEVERABILITY CLAUSE, CODIFICATION AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission has determined that fees for various licenses, permits, and services are necessary to recover the City's cost of providing these services; and

WHEREAS, the City Commission has adopted a comprehensive updated Fee Schedule on June 9, 2015, as subsequently amended; and

WHEREAS, the City Commission desires to make changes to the Local Business Tax classifications to eliminate unused classifications and simplify the remaining categories and classifications beginning for Fiscal Year 2021; and

WHEREAS, the City Commission desires to add the classifications of Office Center and Pramaies and Drug Stores, in order to better reflect types of businesses in the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission revises the Fee Schedule as detailed in Exhibit I, with changes indicated by underline for new text and ~~strikethrough~~ for deleted text.

SECTION 3. SEVERABILITY

If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

SECTION 4. EFFECTIVE DATE

This Resolution shall become effective for Fiscal Year 2021 beginning on October 1, 2020 for which bills are made available on July 1, 2020.




